Note on Newly Reported Deaths

On June 6, 2022 there was a nationwide, temporary pause in the processing of death certificate data while the National Vital Statistics System (NVSS) was undergoing a system-wide upgrade. These upgrades are now complete. However, there may still be a backlog of deaths being processed. The increase in deaths reported this week is largely driven by this pause in reporting.


















COVID-19 VARIANT STRAINS SEQUENCED*

Variant Proportions by Region, Dates of Specimen Collection: June 21, 2022 - June 30, 2022, (N=104):




Monthly Proportion of Variant Lineages, Oklahoma, January 1, 2021 - July 11, 2022 (N=23,970)







Cumulative death rate of reported COVID-19 cases





Cumulative death rate of reported COVID-19 cases in last 7 days



Weekly number of deaths (from all causes)


