 - a) *To be added to all subgrants:* Subgrantee will ensure accurate reporting within the Program Measurements Tool (PMT). Only report services performed by

VOCA funded staff. If the VOCA funded staff member is split funded only report services performed during VOCA time.

- b) *To be added to all subgrants:* Due to budget cuts, prior to accepting award subgrantee must do a Grant Adjustment Notice (GAN) to ensure goals and objectives only reflect VOCA funded services and activities. Goals and Objectives must be modified before the first drawdown. Subgrantee must ensure objectives are measurable and verifiable.
 - c) *To be added to all subgrants:* All VOCA funded subgrantees are required to allocate their grant funds for salaries exclusively for direct victim service provider positions. No grant funds may be used to support administrative or directorial positions that do not provide direct victims services. Direct services refer to immediate assistance and support provided to victims such as crisis intervention, counseling and mental health services, legal services, safety planning, emergency shelter, advocacy, information and referral services.
