Bills:

- SB0005** SB0005, by Sen. Kevin Matthews, D-Tulsa, modifies language related to city-county library commissions. It reduces the number of times the commissions must meet from at least one meeting each month to no fewer than six times per year.
- SB0007** SB0007, by Sen. Blake Stephens, R-Tahlequah, sets the standard time in Oklahoma to be known as Central Daylight Time (CDT), which coincides with daylight saving time. The bill provides it will not be construed to affect the standard time established by United States law governing the movements of common carriers engaged in interstate commerce or the time for performance of an act by an officer or department of the United States, as established by a statute, lawful order, rule, or regulation of the United States or an agency. It provides, as authorized by the Uniform Time Act of 1966, as amended, and notwithstanding any other provisions of law to the contrary by the United States government relating to adoption of daylight saving time by all of the states, Oklahoma elects to adopt such time and elects to continue in force the terms relating to the year-round daylight standard time in Oklahoma. It permits the adoption of daylight saving time to be changed by future legislative action. It provides the bill will only take effect if the United States Congress amends federal law that permits states to enter upon and permanently observe daylight saving time.
- SB0034** SB0034, by Sen. Chuck Hall, R-Perry, corrects statutory references related to the prevention of youth access to tobacco, which was moved from Title 37 to Title 63 in 2016.
- SB0056** SB0056, by Sen. Julie Daniels, R-Bartlesville, extends the sunset date for the Oversight Committee for State Employee Charitable Contributions to July 1, 2025.
- SB0057** SB0057, by Sen. Dave Rader, R-Tulsa, modifies the margin size for documents filed with the county clerk. It requires the top margin to be at least two inches and requires all other margins be at least one inch.
- SB0067** SB0067, by Sen. Brent Howard, R-Altus, makes all state agencies subject to Fleet Management Division reporting requirements except for certain agencies that are exempt from Fleet Management Division oversight and advice but are still subject to required reporting from Fleet Management Division to provide full transparency of the statewide fleet. It adds the Senate president pro tempore and the House speaker to those who the Fleet Management Division is required to submit a statement at the close of each fiscal year showing the financial condition of the Division, an inventory of all motor vehicles, regardless of exemption or oversight status, and such other information regarding the state motor vehicle transportation system as is necessary for a proper understanding of the operation of such system and of the financial condition of the motor pool operations.
- SB0141** SB0141, by Sen. Julia Kirt, D-Oklahoma City, permits receipts to the Oklahoma Friends of the Capitol License Plate Revolving Fund to be used for modification of the State Capitol. The bill modifies the duties of the Friends of the Capitol to include restoration, maintenance, and modification projects and requires approval, rather than consent, of the State Capitol Preservation Commission and the Office of Management and Enterprise Services. The bill extends the sunset date for the Capitol-Medical Center Improvement and Zoning Commission to July 1, 2026. The bill creates the position of Capitol Liaison to the State Capitol Preservation Commission within the Legislative Service Bureau, replacing the bureau's legislative liaison committee. It removes the Long-Range Capitol Planning Commission chair from the Capitol-Medical Center Improvement and Zoning Commission and replaces them with the Capitol Liaison. The bill requires the Department of Public Safety to create a security plan for the State Capitol and Oklahoma State Capitol grounds and the Governor's Mansion. It requires the plan be submitted to the State Capitol Preservation Commission for review and approval. It requires a new plan to be submitted every three years. It requires the Department of Public Safety coordinate with the Office of Management and Enterprise Services to implement and staff the approved security plan. It establishes the responsibilities of the Capitol Liaison. The bill removes language related to the State Capitol Repair Expenditure Oversight Committee. The bill defines applicable terms. The bill extends the sunset date for the State Capitol Preservation Commission to July 1, 2028. The bill requires the

State Capitol Preservation Commission provide the highest quality maintenance, restoration, preservation, enhancement, and modification of and long-term planning for the interior and exterior of the Capitol, Governor's Mansion, and the respective grounds for the perpetual use by the state government and the enjoyment of all persons. It modifies the membership of the State Capitol Preservation Commission. It requires all appointed voting and ex officio non-voting members of the State Capitol Preservation Commission serve at the pleasure of their appointing authority. The bill requires the first chair of the Commission to be the Governor, or designee, who will serve a term of two years. It requires thereafter the chair of the Commission rotate between the Senate president pro tempore or designee, the House speaker or designee, and the Governor or designee for two-year increments in perpetuity. The bill requires the State Capitol Preservation Commission meet at least once per quarter and at the call of the chair as needed. It requires a quorum of the voting members be present for any action taken. It requires the commission be subject to the Oklahoma Open Meeting Act. It provides the commission functions performed by the Governor, Senate president pro tempore, House speaker, Secretary of State, and appointed senators and representatives are additional functions of their other public offices and duties. The bill modifies the duties of the State Capitol Preservation Commission. The bill also modifies the duties of the Capitol Architect and Curator. The bill requires the Office of Management and Enterprise Services (OMES) be the custodian of the Oklahoma State Capitol, Governor's Mansion, and the respective grounds. The bill establishes the State Capitol Preservation Office under the State Capitol Preservation Commission to aid in those duties. It requires all administration and budgetary decisions for the State Capitol Preservation Office be made by the Office of Management and Enterprise Services with authorization by the State Capitol Preservation Commission. It establishes the Oklahoma State Capitol duties of the Office of Management and Enterprise Services. The bill requires the Office of Management and Enterprise Services to employ all staff and consultants necessary to perform the duties of the Office including, but not limited to, a licensed architect. The bill gives the Oklahoma Arts Council the responsibility to acquire, maintain, preserve, or restore any state-owned art that is in storage or on display in the State Capitol, Governor's Mansion, and the respective grounds. It authorizes the council to hold exhibitions and commissions to display art to the general public. It permits the council to request direct appropriations or submit requests to the Office of Management and Enterprise Services. It repeals language related to cooperation between the State Capitol Preservation Commission and the branches of government.

- SB0180** SB0180, by Sen. Micheal Bergstrom, R-Adair, requires all rulemaking authority delegated by the Legislature to executive branch agencies be used only to implement law or policy as set by the Legislature. The bill requires, within three years of the bill's effective date, all administrative rules, including those approved before the bill's effective date, to include a specific reference to the statutory provision that delegates the authority for promulgation of the rule. The bill modifies the definition of the term "rule."
- SB0184** SB0184, by Sen. Carri Hicks, D-Oklahoma City, removes the Legislature's preemption to control smoking in public places. The bill permits political subdivisions to adopt regulations to control or prohibit smoking or vaping in public places or properties owned or operated by the respective governing bodies. It permits the laws to be more, but not less, stringent than those in the Smoking in Public Places and Indoor Workplaces Act.
- SB0302** SB0302, by Sen. Roger Thompson, R-Okemah, creates the Payroll System Transition Revolving Fund to be used by the Office of Management and Enterprise Services to transition agencies to a payroll system that pays employees every two weeks. The bill removes all reference to a multi-monthly payroll.
- SB0460** SB0460, by Sen. Roger Thompson, R-Okemah, amends the definition of the term "video services" as it pertains to their regulation.
- SB0500** SB0500, by Sen. Paul Rosino, R-Oklahoma City, grants up to a 10-day work leave for any state employee upon the initial placement of a child in the custody of the Department of Human Services in their home, as long as the request is made in advance.
- SB0507** SB0507, by Sen. Chuck Hall, R-Perry, requires each member of the county board of equalization to be required to attend and successfully complete a course of instruction consisting of at least six hours for purposes of instructing the members about the duties imposed on the board by law. It provides the initial six-hour training to only be required for the member's first term.
- SB0508** SB0508, by Sen. Chuck Hall, R-Perry, clarifies the provisions of the Public Competitive Bidding Act of 1974 will not apply to a monetary donation made to a municipality for a specific public purpose which has been approved by the municipal government.
- SB0515** SB0515, by Sen. Micheal Bergstrom, R-Adair, modifies the provisions for rule submission under the Administrative Procedures Act.
- SB0580** SB0580, by Sen. Chuck Hall, R-Perry, modifies the definition of the term "area of operation" as used in the Oklahoma Housing Authority Act.
- SB0598** SB0598, by Sen. Julia Kirt, D-Oklahoma City, updates terminology related to persons with disabilities.
- SB0708** SB0708, by Sen. Roland Pederson, R-Burlington, requires that in each court hearing related to a deprived child the court make a finding as to whether the attorney appointed for the child has complied with certain requirements.
- SB0951** SB0951, by Sen. Chris Kidd, R-Waurika, increases the monthly travel allowance for each county commissioner and sheriff to \$1,000.
- SB0952** SB0952, by Sen. Chris Kidd, R-Waurika, increases the value of items of which the purchase or lease by county officials must be placed on the agenda of a public meeting for approval to \$2,500.
- SB0996** SB0996, by Sen. Cody Rogers, R-Tulsa, modifies language related to the Oklahoma Tax Commission entering into contractual agreements to assess, collect, and enforce taxes and penalties.
