  - a. Financial Report: Mr. Lewis reported on the year end financial report. The report states we have spent about \$1.2 million which is \$200,000 over our revenue. This spending is good as additional money needs to be spent from additional grants. Mr. Lewis stated each month had around \$100,000 in expenditures and have spent \$93,000 in state funding while the rest is grant funds. Grant fund balances were presented, FY21 and FY22 grants completed. Remaining balances for FY23 are \$313,325.73 and for FY24 \$612,620.03., with our new grant (FY24) starting October 1, 2024.
  - b. Expenditures: Ms. Randle shared invoices coming in can be a slow process. One example was while the work with Oklahoma State is completed, invoicing is not. Discussion between Ms. Randle and Mr. Lewis stated that all the work needs to be completed by September 30, 2024, invoices can be submitted after, up to a year.
