# DISCUSSION:

### Partners in Policymaking & Youth Leadership Forum

Dr. Mays reported that Partners in Policymaking would be starting next month with 31 applicants who have been selected. We're working on selecting a date for PIP Graduate Academy later this year, which will be a one-day session. Dates for YLF has been selected, June 9-13. Dr. Mays reported he had presented to around 25 people at a session during the Inclusive Communications Conference.

Ms. Duplan mentioned that LEND does a survey every year for their alumni and that maybe we could implement something like that. Other ideas from Ms. Bond include having graduates make short video reels about what they've done.

### Self-Advocacy Trainings

Ms. Davis reported the contract with Galt hasn't been finished yet. One training course for Project SEARCH students in Norman is scheduled and working on scheduling a training course with Alicia Murie (past Council Member). Ms. Davis reported she spoke at the Inclusive Communications Conference, presenting her LEND studies on the effectiveness of one-page profiles.

### Council Marketing/Outreach:

Ms. Randle presented social media outreach information. Engagement on social media pages (Council, YLF, PIP, Self-Advocacy) has been good with more people clicking on links and engaging. This shows posts are reaching the right audience and sparking their interest.

Ms. Bond asked if each of the pages shares each other's content. Ms. Patterson answered yes, we do.

### a) OK STABLE updates:

Ms. Duplan reported that from May to July 21, there were 63 new ABLE accounts opened.

Ms. Duplan mentioned that during the month of August, there is a special promotion to encourage people to open ABLE accounts. If someone opens an account and starts it with the required \$25, that account will receive \$25. She also mentioned she and Ms. Wanda Felty will be having a virtual ABLE account training on Saturday, August 23.

## VII. New Business:

#### Candidate Questionnaire:

The committee discussed Questions and Answers over several topics to send to Oklahoma Gubernatorial and possibly State Legislative Candidates. Questions are sorted into Charing the LifeCourse Life Domains and include questions about Medicaid, education, voting access, civil rights.

Guest Ms. Blose about adding a comment to connect candidates to someone who could help them with more information. Ms. Duplan agreed this would be a good idea, for those who may not have advisors.

Guest Ms. Blose suggested maybe providing some resources and best practices for candidates to help them learn more, maybe a website. Ms. Duplan mentioned that maybe we connect them to the UCEDDs.

The committee discussed using the word 'ensure' in some parts of the document as it could slant position. Staff will review the usage of this word. Questions to review include underneath the healthy living domain and the last question. Ideas to use to replace ensure include 'What ideas do you have?'

There was discussion about the question about disability history studies in all grade levels, should remove the word 'all'. The committee thought to remove the question in entirety, given the current climate.

Ms. Duplan suggested this wording for the question with ensure under healthy living: What is your plan to help Oklahomans with intellectual and developmental disabilities (I/DD) remain in their communities and out of costly Medicaid funded institutions such as nursing homes and intermediate care facilities (ICFs).

Ms. Blose announced that AutismOklahoma is hosting a virtual training about SSI, with SSI, targeting parents who are reaching retirement age in the fall.

According to the U.S. Centers for Disease Control and Prevention (CDC), 1 in 4 adults in the U.S. has a disability. This includes impairments with vision, hearing, mobility, and cognition. Many people with disabilities rely on programs and services funded by the state to support them in maintaining their health, access to education and employment, and participate in their communities.

To put this into perspective, Oklahoma has over 62,500 Oklahomans who have an intellectual or developmental disability (I/DD). These Oklahomans, along with their families and caregivers, represent a significant and vital portion of the Oklahoma electorate. Their success in achieving independence, access to employment, quality education, and full community inclusion is directly tied to the overall health and prosperity of our state. This number is based on the prevalence rate which is 1.58% of the population, per the Health and Human Services National Health Interview Survey (NHIS-D).

The Developmental Disabilities Council of Oklahoma (DDCO) requests your position(s) on the questions below. All candidate responses will be provided in one document for Oklahomans. Questions are organized by the Charting the LifeCourse (CtLC) Life Domains. Life domains are the different aspects and life experiences that we consider as we age and grow. We lead whole lives made of specific, connected and integrated life domains that are important to a good quality of life. Life domains help us think about the current reality in our lives as well as the life experiences we'd like to have, which can lead us to the good life we want.

We understand these questions are specific to issues facing Oklahomans with intellectual/developmental disabilities (I/DD) and their families. If you would like to gain deeper insight or discuss these topics further including learning more about Charting the LifeCourse, staff and members of the Developmental Disabilities Council of Oklahoma (DDCO) (people with developmental disabilities, family members, and key state agency representatives) are available as a resource. #### **DAILY LIFE & EMPLOYMENT**

What a person does as part of everyday life (school, employment, volunteering, communication, routines, life skills, etc.).

**Question:** College and University tuition continues to rise. While Oklahoma has increased inclusive college opportunities for students with intellectual/developmental disabilities (I/DD), the cost of these programs can be twice that of a typical college student. What are your plans to support students with I/DD with these cost increases?

**Question**: What are your plans to help people with disabilities receive the necessary support to find and maintain jobs in the community that offer equal wages to those without disabilities, which will help to address the high unemployment rates for people with disabilities?



Where and how someone lives (housing and living options, community access, transportation, home adaptations and modifications).

**Question:** What is your plan to improve Oklahoma's transportation systems to meet the needs of all Oklahomans, including people with I/DD who are non-drivers?

**Question:** What is your plan to increase access to available, accessible, and affordable housing for people with disabilities who are seeking housing or who are experiencing homelessness?



Managing and accessing health care and staying well (medical, mental health, behavioral health, developmental, wellness and nutrition).

**Question:** What is your plan to address potential federal reductions to the current level of Medicaid funding so Oklahomans with I/DD and their families can have the support and services they currently receive to maintain their health and independence?

**Question:** What is your plan to help people with intellectual/developmental disabilities (I/DD) remain in their communities and out of costly Medicaid-funded institutions such as nursing homes or intermediate care facilities (ICFs)?



Staying safe and secure (emergencies, well-being, guardianship options, legal rights and issues).

**Question:** What plans do you have to address Oklahoma's community-based direct care workforce crisis, the pressure it puts upon family caregivers and provider agencies, and the barriers it creates to ensuring people with disabilities have access to a qualified essential workforce?

Question: What plans do you have to address Oklahoma's teacher workforce crisis, including the need for special educators and paraprofessionals to ensure students with intellectual/developmental disabilities (I/DD) have access and ensure students are prepared for the workforce or a postsecondary opportunity after completing high school?



Building friendships and relationships, leisure activities, personal networks, and faith community.

**Question**: Isolation and loneliness are significant public health concerns with widespread impacts on mental and physical well-being for everyone and have plagued people with I/DD for too long. What plans do you have to promote policies that promote social inclusion to increase positive relationships and improve the mental and physical well-being for everyone?



Building valued roles, making choices, setting goals, assuming responsibility and driving how one's own life is lived.

Oklahomans with I/DD deserve to understand and exercise their personal and civil rights to lead safe and successful lives as independently as possible, and they deserve equal protection when their rights are infringed upon.

**Question**: What will you do to increase the protection for the personal and civil rights of Oklahomans with I/DD?

**Question:** What is your plan to appoint people with lived experience (people with disabilities or their family members) to policy making positions which includes agencies, boards, and commissions, throughout your administration?
