WHEREAS, the Mississippi State Board of Dental Examiners has received documentation regarding violations of Board Regulation No. 43 (Dental Advertising) by Daryl Lance Johnson, D.M.D., Mississippi Dental License No. 2826-94 (hereinafter referred to as "Licensee"); and

WHEREAS, Licensee may be charged with violation of Subsections (1)(b) and (1)(l)(iv) of Miss. Code Ann. Section 73-9-61, as amended, which states:

(1) Upon satisfactory proof, and in accordance with statutory provisions elsewhere set out for such hearings and protecting the rights of the accused as well as the public, the State Board of Dental Examiners may deny the issuance or renewal of a license or may revoke or suspend the license of any licensed dentist or dental hygienist practicing in the State of Mississippi, or take any other action in relation to the license as the board may deem proper under the circumstances, for any of the following reasons:

(b) Willful violation of any of the rules or regulations duly promulgated by the board, or of any of the rules or regulations duly promulgated by the appropriate dental licensure agency of another state or jurisdiction.

(l) Any unprofessional conduct to be determined by the board on a case-by-case basis, which shall include, but not be restricted to, the following:

(iv) Advertising that is false, deceptive or misleading.

NOW, THEREFORE, the Mississippi State Board of Dental Examiners, with the consent of Licensee as indicated by Licensee's joinder herein, does hereby order:

1. In all future advertisements, Licensee will thoroughly review said advertisements and ensure that each complies in every respect with the Rules and Regulations of the Board.
2. Licensee shall pay, pursuant to Section 73-9-61(4)(a), a monetary penalty of \$800.00.
3. Licensee shall pay, pursuant to Section 73-9-61(4)(d), the reasonable costs of these proceedings in an amount to be determined by the Board.
4. Licensee shall provide and furnish to the Board within ten (10) days of entry of this Order, any and all documentation which verifies that Licensee has complied with all requirements of Board Regulation 41, dealing with Continuing Dental Education, and Board Regulation 45, dealing with Cardiopulmonary Resuscitation.


