

The invoices will be sent to the laboratory primary point of contact unless we have a separately identified individual on file for receiving invoices. If you would like the invoices to be physically mailed or emailed to a different person, please let us know so that we can make that adjustment.

We emailed out an extension letter to all of our currently accredited laboratories' primary point of contact on August 30, 2024, to ensure that nobody experiences a lapse in accreditation due to renewal processing time. Methylene Chloride Regulation:

As mentioned in our <u>previous newsletter</u>, EPA finalized a rule limiting the use, purchase, and manufacturing of methylene chloride (MeCl₂), effective July 8, 2024.

EPA ENVIRONMENTAL RESPONSE LABORATORY NETWORK (ERLN):

The <u>ERLN</u> is a voluntary and comprehensive laboratory network prepared to be activated in response to a variety of analytical needs in the face of an environmental emergency response and recovery situation.

In the event of a large environmental emergency, it's estimated that there would be around 10,000 samples needing urgent environmental analysis. The purpose of the ERLN is to ensure that if there is an emergency on this scale, that the country has the capacity needed to perform the needed testing and provide reliable, high-quality analytical data to move forward and make timely, critical decisions.

When a laboratory decides to become a member of the ERLN, not only are they participating in a critical component of national safety and security, but they also gain access to large-scale training and exercise opportunities, including networking and building relationships with other environmental laboratories across the nation.
