

### 10. Discussion of proposed changes to Chapter 515 Management of Solid Waste.

The Department of Environmental Quality is presenting, for discussion purposes only, proposed revision to Chapter 515. Revisions are being proposed to Subchapter 11 Liner Design, Flexible Membrane Liner (FML) thickness. The change would require the minimum thickness of all FMLs to be 60 mils. The current rule allows a minimum liner thickness of 30 mils for non-HDPE liner material.
