## OKLAHOMA DEPARTMENT OF ENVIRONMENTAL QUALITY NOTICE – DRAFT PERMIT MODIFICATION

The Oklahoma Department of Environmental Quality ("DEQ") received an application for a solid waste permit modification at Oklahoma Green to Gold Recycling, LLC at 43470 Moccasin Trail Rd Meeker, Ok 74855, located in the East Half of the East Half of the Southeast Quarter of the Southwest Quarter (E/2 E/2 SE/4 SW/4) in Section Nine (9) Township Eleven (11) North, Range Four (4) East of the Indian Meridian, Pottawatomie County, Oklahoma. The application was filed by Oklahoma Green to Gold Recycling, LLC on November 5, 2024.

DEQ has tentatively found that the application meets the requirements of Title 27A of the Oklahoma Statutes, Section 2-1-101, Section 2-10-101, and rules of the DEQ, Oklahoma Administrative Code ("OAC"), Title 252, Chapters 4 and 515, and has prepared a draft permit modification for public review.

The draft permit modification and its conditions propose Oklahoma Green to Gold Recycling, LLC to change its composting facility class from Class II to Class III by increasing the amount of feedstock received for composting to greater than one hundred (100) tons, or two hundred (200) cubic yards, of Type 1 and Type 2 feedstocks per year. Oklahoma Green to Gold Recycling, LLC is also requesting to expand the permitted boundary of the existing facility. These capacity and construction changes will aid Oklahoma Green to Gold Recycling, LLC in maintaining composting operations with increasing solid waste demands. The application includes a variance request for conducting all waste management operations indoors on concrete surface or inside enclosed containers in lieu of conducting groundwater monitoring in accordance with OAC 252:515-43-91.

The application, draft permit modification, and related documents may be reviewed during normal business hours at the Central Records Office, Oklahoma Department of Environmental Quality, located on the 2nd floor of the DEQ building at 707 North Robinson, P. Persons wishing to comment on the draft permit modification should submit their comments in writing to DEQ at the above address or electronically to DEQ at the website address above. Also, any person may request, in writing, a formal public meeting to present written or oral statements and data concerning the draft permit modification. A request for a public meeting must identify the nature of the issues to be raised in the meeting. If DEQ determines, based on the requests it receives, that there is a significant degree of public interest in the draft permit modification, it will schedule a public meeting and provide notice of the date, time and place.

Written comments and requests for a public meeting must be received by DEQ within 30 days after the date of this publication at the DEQ address given above. More specific information
