RESULTS

Below are the results from the first and second rounds of testing of drinking water for lead that was conducted at Community Action Agency of OKC - Kiddie Village Head Start. The initial sampling event occurred on April 4, 2024. The resampling event occurred on July 29, 2025.

In the initial sampling, eleven (11) outlets were tested resulting in a total of twenty-two (22) samples being sent to the lab.

- Twenty-one (21) samples had no detectable level of lead.
- One (1) sample had a low detection of lead between 1.0 and 14.9 μg/L.
- Zero (0) samples had a high detection of lead equal to or above 15.0 μg/L.

In the resampling, one (1) outlet was tested resulting in a total of two (2) samples being sent to the lab.

• All two (2) samples had no detectable level of lead.
