## Third AMENDMENT <br> TO <br> CONTRACT

This Third AMENDMENT ("Third Amendment") is effective as of the last date signed by either party ("Third Amendment Effective Date") and amends and supplements that certain Contract by and between Securus Technologies, LLC ("Securus") and the State of Oklahoma Department of Corrections ("ODOC") effective as of February 24, 2020 (the "Contract").

WHEREAS, ODOC and Securus are parties to the Contract and desire to amend the terms as stated herein;
NOW, THEREFORE, as of the Third Amendment Effective Date and in consideration of the mutual promises and covenants contained herein, the parties agree as follows:

1. Term. This Third Amendment shall commence on the last date signed by either party and shall remain in effect through the term of the Contract. The parties hereby agree to renew the Contract for an additional year, resulting in a new termination date of February 23, 2024. By mutual consent of the parties hereto, it is intended that there shall be seven remaining annual options to renew, subject to the terms and conditions set forth in the Contract and herein.
2. Securus agrees to install services at the Great Plains Correctional Center located in Hinton, Oklahoma.
3. Amend the Value-Added Plan identified in Attachment G, Page 78, Approved Services. ODOC agrees to exchange the remaining 6 Wireless Containment Systems (WCS) managed access solutions to be completed on the initial 8 years of the contract for Mobile Cellular Assessments to be supported by Securus. In the 23-24 renewal period, Securus agrees to provide the two Mobile Cellular Assessment Teams, to include mobile cellular assessment equipment, two vehicles and 5 full time staff to perform the mobile cellular assessments, interpret data and provide actionable intelligence to the ODOC to combat the cellphone activity within ODOC prisons. In the 24-25 renewal period, Securus agrees to add 3 additional Mobile Cellular Assessment Teams to include mobile cellular assessment equipment, 3 vehicles and 6 full time staff to perform mobile cellular assessments, interpret data and provide actionable intelligence to the ODOC to combat cellphone activity within ODOC prisons. The 5 mobile cellular assessment teams and 11 staff will remain in sequential renewal periods remaining on the contract.
4. Amend the Value-Added Plan identified in Attachment G, Page 79 \#1, Approved Services: Securus agrees to continue to provide the 1 additional full-time on-site analysts/technician employee agreed to in the 22-23 amendment located at the ODOC Oklahoma City, STI Office for the purpose of listening to SCP Next Gen inmate system phone calls and providing investigative assistance in sequential renewal periods remaining on the contract.
5. Amend the Value-Added Plan identified in Attachment G Page 79 \#4, Approved Services: Securus agrees to fund Cellebrite Premium Unlimited in the remaining years of the contract.
6. Securus agrees to add 1 additional full-time on-site analyst/technician employee to be located at the ODOC Oklahoma City STI Office for the purpose of combating Human Trafficking.
7. Securus agrees to continue Securus Word Alert agreed to in the Second contract amendment for sequential renewal periods remaining on the contract. Securus Word Alert is a safety, security, and investigative feature of the NextGen Secure Communications Platform which uses speech-to-text technology to transcribe the audio in calls to text and allows investigators to search text transcripts for specified words and phrases. Securus Word Alert also enables investigators to request English translations of transcripts that are in other languages.
8. Securus agrees to fund debit deposit automation between the ODOC Inmate Banking Software provider (ATG) and the Securus communication platform for the 23-24 contract year and sequential renewal periods remaining on the contract years unless mutually agreed upon by both parties. This integration will be completed within 120 days of the Third Amendment Effective Date.
9. The ODOC agrees to implement Securus Text Connect. Securus' Text Connect Application ("STC") allows for two-way electronic communication (up to a maximum of 160 characters per message) between friends and family and an incarcerated individual on a near real-time and non-delayed basis, similar to mobile phone text functionality. Friends and family send and receive messages using the Securus mobile app and must have a free Securus Online account to access. Incarcerated individuals access the STC functionality through Provider's tablets. Provider will provide STC at no cost to Customer. STC includes an integrated agency interface as part of NextGen SCP that Customer can utilize to monitor communications and otherwise administer the STC product. STC messages will be accessible to the incarcerated individual for a period of 60 days, but available to Customer for 60 months; Customer is solely responsible for preserving any messages beyond that storage period by downloading them to a separate storage medium. STC will be deployed in this Authorization with Word Alert functionality.
