



7th AMENDMENT

ODOC of OKLAHOMA – DEPARTMENT OF CORRECTIONS

This 7th AMENDMENT (“7th Amendment”) amends and supplements that certain Contract entered into by and between Securus Technologies, LLC (“Securus” or “Provider”) and ODOC of Oklahoma - Department of Corrections (“ODOC” or “Customer”) effective February 20, 2020, as amended (the “Agreement”).

WHEREAS Customer and Provider previously agreed, among other things, to the deployment of Securus’ Text Connect Application (“STC”).

WHEREAS on or after July 24, 2024 (the “7th Amendment Effective Date”), Provider will enhance the functionality of STC to include the capability to send eCards through the Application, and adjust STC pricing to a units-based compensation model.

WHEREAS Customer and Provider wish to amend the Agreement to memorialize the enablement of STC eCard capability, and to adjust STC pricing to the units-based compensation model described herein.

NOW, THEREFORE, as of the 7th Amendment Effective Date and in consideration of the mutual promises and covenants contained herein, the parties agree as follows:

1. Definitions. Capitalized terms used and not defined in this 7th Amendment have the respective meanings assigned to them in the Agreement.
2. Term. This 7th Amendment shall commence on the 7th Amendment Effective Date and shall remain in effect through the Term of the Agreement. Notwithstanding anything to the contrary, the terms and conditions of the Agreement shall continue to apply for so long as we continue to provide the Applications to you after the expiration or earlier termination of this Agreement.
3. STC eCard Capability. STC eCard capability will be enabled as of the 7th Amendment Effective Date.
4. Securus Text Connect Compensation. As of the 7th Amendment Effective Date, the table under section 9 of the 3rd Amendment is hereby deleted in its entirety and replaced with the following:
