



REAL ID DOCUMENT CHECKLIST



The deadline for requiring a REAL ID compliant credential to board a domestic airline flight has been extended to May 3, 2023. Until that date, TSA will accept any state-issued current Oklahoma driver license or identification card. The deadline extension may not apply to other federal facilities. DHS recommends that you contact the federal agency you plan to visit in advance, to obtain information regarding identification requirements.

- 1.** You will need to provide proof of identity/lawful presence in the U.S. The document must be an original or a certified copy. Notarized documents are not accepted. Please select one (1) document from the list below:

NOTE: For driver license and identification card purposes, tag agents may only serve U.S. citizens and permanent residents. All other non-citizens must visit a DPS facility.

Please bring one (1) document from the list below for every name change from your Section 1 document to your current name:

- 2.** You must provide your Social Security number for verification. Proof of the number is not required - it is only required that you know your number.

- 3.** You must provide two (2) proofs of your current Oklahoma address. Both your name and current residential address must appear on the documents. Please bring two (2) documents from the list below **OR** one document from the list below and any current or expired Oklahoma state-issued driver license or ID card with the same name and address.
