## Instructions to Private Bar on Noncompliance With An Order of Child Support Order to Revoke Driving Privilege DPS Form

2. Send a copy of the **Order and DPS form** to DPS.
3. Send a copy of the **Order** to other interested parties, e.g. the custodial parent and Child Support Services (“CSS”). Neither CSS nor the custodial parent gets a copy of the DPS form.
4. **DO NOT FILE THE DPS FORM IN DISTRICT COURT.**
