- Under Voter Services, select Respond to an Address Confirmation Notice.
- Enter the 8 digits (######-##) printed above your name on the other side of this card.
- Do not mail the Return Card.

- Fill out, sign and date the **Return Card**.
- Fold the card so that the State Election Board's address is on the outside.

Why did I receive this notice? You may have been selected for one or more of these reasons: your name, birth date, driver license number, or the last four digits of your Social Security number appear to match another voter in Oklahoma; a first-class mailing from your County Election Board was returned by the post office marked undeliverable; or you have not voted or updated your registration since November 1, 2020.
