### **Candidate Filing Dates**

Monday, December 4, 2023 (8 a.m. – 5 p.m.) Tuesday, December 5, 2023 (8 a.m. – 5 p.m.) Wednesday, December 6, 2023 (8 a.m. – 5 p.m.)

### **Election Date**

March 5, 2024 7 a.m. – 7 p.m.

### **Candidate eligibility and qualifications**

- Only candidates who are members of political parties currently recognized in the State of Oklahoma may file a Statement of Candidacy for the 2024 Presidential Preferential Primary. A list of recognized political parties in Oklahoma is available on the Oklahoma State Election Board website at <u>oklahoma.gov/elections</u>.
- Candidates must swear or affirm that they are fully qualified to become a candidate for the office of President of the United States and that they will be fully qualified to hold said office.
- Candidates must also swear or affirm that they have filed a Statement of Candidacy with the Federal Election Commission and have raised and expended not less than \$5,000 for said office.

### Where to file


The Oklahoma Statement of Candidacy, accompanied by a filing fee or a petition in support of the candidacy, must be submitted to the Secretary of the Oklahoma State Election Board.

### **PRESIDENT OF THE UNITED STATES** Candidate Filing Instructions 2024 Oklahoma Presidential Preferential Primary Election

### How to file

- Candidates or their agents may appear in person to submit their Oklahoma Statement of Candidacy between the hours of 8 a.m. and 5 p.m. during the three-day candidate filing period prescribed by state law for this election.
- Candidates may submit the Oklahoma Statement of Candidacy by United States Mail or another delivery service. The Oklahoma Statement of Candidacy must arrive in the State Election Board office between the hours of 8 a.m. and 5 p.m. during the three-day candidate filing period.
- Early, late, or incomplete submissions cannot be accepted.
- Candidates must personally sign the Oklahoma Statement of Candidacy form. The Oklahoma Statement of Candidacy form submitted to the Secretary of the State Election Board must bear the candidate's original signature, which shall be witnessed by a notary public.
- Oklahoma Statement of Candidacy forms cannot be accepted by fax or by email.

### Filing fee or petition

The Oklahoma Statement of Candidacy shall be accompanied by **<u>one</u>** of the following:

• A cashier's check or certified check, payable to the Secretary of the State Election Board, in the amount of five-thousand dollars (\$5,000.00). Campaign checks, personal checks, and cash cannot be accepted.

### OR

• A petition supporting the candidacy signed by one percent (1%) of the registered voters in each congressional district eligible to vote for a candidate in the Presidential Preferential Primary Election, or by one thousand (1,000) registered voters in each congressional district eligible to vote for a candidate in the election, whichever is less, as reflected by the latest January 15 Voter Registration Report, which is available on the State Election Board website at <u>oklahoma.gov/elections/voter-registration/voter-registration-statistics.html</u>. [26 O.S. Supp. 2017, Section 20-102] Oklahoma has five congressional districts.

### **Candidate's Name**

The candidate's name will be printed on the ballot as it is entered on the first line of the Oklahoma Statement of Candidacy; however, no candidate shall have any prefix, suffix, or title placed before or after the candidate's name. The candidate's full legal name must be provided on the Oklahoma Statement of Candidacy.

### Candidate Eligibility and Qualifications 2024 Oklahoma Presidential Preferential Primary Election

### **United States Constitution and Oklahoma Statutes**

### United States Constitution, in Article II, Section 1:


"No Person except a natural born Citizen, or a Citizen of the United States, at the time of the Adoption of this Constitution, shall be eligible to the Office of President; neither shall any Person be eligible to that Office who shall not have attained to the Age of thirty five Years, and been fourteen Years a Resident within the United States."

### Oklahoma Statutes, 2017 Supp., Title 26, Section 20-102:

"A. Candidates for the nomination for President of the United States shall file with the Secretary of the State Election Board. Such candidates shall be members of political parties recognized under the laws of the State of Oklahoma and shall have filed a statement of candidacy with the Federal Election Commission and shall have raised and expended not less than Five Thousand Dollars (\$5,000.00) for the office. The candidates shall be required to swear an oath or affirm that they meet the aforementioned qualifications, and their signatures shall be witnessed by a notary public. Such filing beginning at 8:00 a.m. on the first Monday in December and ending at 5:00 p.m. on the next succeeding Wednesday, or at a time prescribed by the State Election Board for a Presidential Preferential Primary to be held on a date other than the first Tuesday in March. A statement of candidacy must be accompanied by a petition supporting a candidate's filing signed by one percent (1%) of the registered voters in each congressional district eligible to vote for a candidate or one thousand (1,000) registered voters in each congressional district eligible to vote for a candidate, whichever is less, as reflected by the latest January 15 registration report; or by a cashier's check or certified check in the amount of Five Thousand Dollars (\$5,000.00). The State Election Board shall cause the names of all candidates who have filed within the proper time to be printed on the official ballots. The ballots shall be prepared as provided for by law. Voters shall be restricted to one vote for the candidate of his or her choice of the political party in which the voter is registered.

B. Each page of a petition supporting a candidate's filing shall identify the county and the congressional district, and shall contain the names of registered voters in only one congressional district and in only one county.

C. Each page of a petition supporting a candidate's filing shall be verified. Verification shall be made in substantial compliance with the provisions of Section 6 of Title 34 of the Oklahoma Statutes."
