



## OKLAHOMA STATE ELECTION BOARD

### DECLARATION OF ELECTION EMERGENCY 2026-03

**WHEREAS** on or about March 31, 2026, the Secretary of the Osage County Election Board was notified that damage occurred at a polling place in Osage County, Oklahoma, causing the need to relocate the polling place located at the Gilcrease Hills Club House, 1919 W. Seminole St., Tulsa, OK 74127; and

**WHEREAS** this location serves as a polling place for Precincts 310 and 311 in Osage County; and

**WHEREAS** voting cannot occur at this location due to the damage to the property.


**WHEREAS** the Osage County Election Board Secretary has requested to temporarily relocate the polling place for Precincts 310 and 311 to a temporary location outside of the precincts' boundaries to Gilcrease Hills Baptist Church, 2001 W. Newton St., Tulsa, OK 74127 for the elections being held on Tuesday, April 7, 2026 and June 16, 2026.

**NOW, THEREFORE**, I, Paul Ziriaux, Secretary of the State Election Board, pursuant to the power vested in me by Paragraph 1 of Subsection A of Section 22-101 of Title 26 of the Oklahoma Statutes hereby declare and order the following:

1. An election emergency exists in Precincts 310 and 311 in Osage County for the elections being held on Tuesday, April 7, 2026, because it is less than thirty (30) days from the date of an election. See 26 O.S. § 3-118.
2. The Secretary of the Osage County Election Board is authorized to temporarily relocate the polling place for Precincts 310 and 311 to Gilcrease Hills Baptist Church, 2001 W. Newton St., Tulsa, OK 74127.
3. The County Election Board Secretary shall make every reasonable effort to notify the public and local news media of the relocation of the polling place for Precincts 310 and 311.
3. The inspectors, judges, clerks, and other precinct officials assigned to Precincts 310 and 311 for the election held on Tuesday, April 7, 2026, and June 16, 2026, relocate the necessary voting equipment, ballots, and materials in order to conduct voting for this precinct to Gilcrease Hills Baptist Church, 2001 W. Newton St., Tulsa, OK 74127.


