#### BUSINESS CONDUCTED AT THE MEETING

1. **BUSINESS CONDUCTED:** Consideration and action regarding the minutes of the meeting held November 9, 2010. **ACTION TAKEN:** Mr. Watkins moved that the minutes of the meeting held on November 9, 2010, be approved. Mr. Prince seconded the motion. **ROLL CALL VOTE:** Mr. Prince-aye; Mr. Watkins-aye. Motion passed, 2-0.

**BUSINESS CONDUCTED:** Board to vote/take appropriate action regarding the case and/or State Question No. 755. **ACTION TAKEN:** Mr. Watkins moved that the State Election Board appeal the preliminary injunction granted against the State Election Board. Mr. Prince seconded the motion. **ROLL CALL VOTE:** Mr. Prince-aye; Mr. Watkins-aye. Motion passed, 2-0.
