

MINUTES

OF THE STATE ELECTION BOARD AT ITS MEETING

April 30, 2019

The State Election Board met in a Special meeting at 3:00 p.m. in Room G28 of the State Capitol Building. Advance notice of the meeting was performed by filing a written notice with the Secretary of State on April 15, 2019, at 10:35 a.m. A copy of the agenda is attached.

Secretary Paul Ziriaux noted publicly, just prior to the meeting, that Mr. Montgomery, Dr. Mauldin, and Ms. Cline have all been recently confirmed by the Oklahoma State Senate as Members of the State Election Board.


