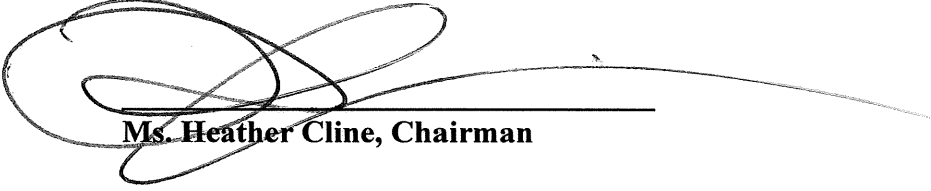
BUSINESS CONDUCTED AT THE MEETING:

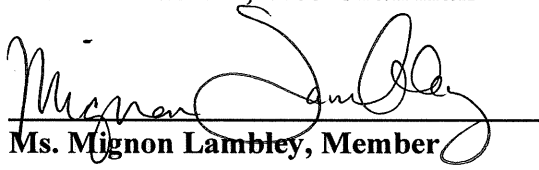
