The State Election Board met in a Special meeting at 5:00 p.m. in Room 419-A of the State Capitol Building. Advance notice of the meeting was performed by filing a written notice with the Secretary of State on January 11, 2012, at 4:02 p.m. A copy of the agenda is attached.

Supp. 2011, 307 (B)(4) **ACTION TAKEN:** Based on the advice received from Martha Kulmacz, counsel with the Attorney General's office, Mr. Roth moved that the Board enter into Executive session. Mr. Buchanan seconded the motion. **ROLL CALL VOTE:** Mr. Prince-aye; Mr. Roth-aye; Mr. Buchanan-aye. Motion passed, 3-0.
