EXECUTIVE SUMMARY

INTRODUCTION

Pursuant to <u>26 O.S. § 3-130</u>, State Election Board Secretary Paul Ziriax directed Okfuskee County Election Board to conduct a post-election manual tabulation audit of the County Commissioner Special Election held on Tuesday, November 14, 2023.

The November post-election audit, which was open to the public, was conducted on Tuesday, November 28, 2023. The County Election Board posted a public notice of the date, time and location of its post-election audit at least 48 hours in advance.

The post-election audit was conducted pursuant to the procedures developed in advance under the direction of the Secretary of the State Election Board. One randomly selected precinct and in-person absentee ballots were manually audited.

The results of the manual post-election tabulation audit confirmed the certified election results. The post-election audits identified zero differences compared to the certified election results.
