EXECUTIVE SUMMARY

INTRODUCTION

Pursuant to <u>26 O.S. § 3-130</u>, State Election Board Secretary Paul Ziriax directed seventy-five (75) county election boards to conduct post-election manual tabulation audits of the Board of Education General Elections, Statutory Municipal Elections, and Special Elections held on April 4, 2023.

The post-election audits were conducted during the period of Monday, May 22 through Thursday, May 25, 2023 and were open to the public. Each County Election Board posted a public notice of the date, time and location of its post-election audit at least 48 hours in advance.

The post-election audits were conducted pursuant to the procedures developed in advance under the direction of the Secretary of the State Election Board.

Participating counties, precincts, and races were randomly selected for the post-election audits. Additionally, two candidate-requested recounts of the April 4, 2023 elections are also included in this report.

The post-election tabulation audits confirmed the certified election results, with the results from each audit matching the certified vote totals. The post-election audit also identified a minor procedural issue, which is discussed in the "Additional Findings" section.

ADDITIONAL FINDINGS

Although the post-election tabulation audits confirmed that the certified results were tabulated correctly in the audited races, a minor procedural issue involving the storage of one "spoiled" ballot – which had no effect on the election totals or outcome of the election – was revealed in Washita County. Details of this issue are included in Section 3 of this report.

During the post-election audit conducted in Washita County on May 24, 2023, one uncounted, spoiled ballot was discovered in the sealed ballot transfer case containing Election Day ballots cast in Precinct 750030.

Upon a closer inspection of the ballot and after conducting the manual recount, it was determined that the ballot was a "spoiled" ballot that had mistakenly been placed in the transfer case following the election. (Protocol directs precinct officials to destroy "spoiled ballots" and place the destroyed ballots in the "Spoiled and Discarded Ballots Bag" when the voter is issued a new ballot.) While the "spoiled" ballot was mistakenly stored in the transfer case following the election, the ballot was not counted on Election Day and the improper storage of the ballot did not affect the outcome of the election or the ballot totals.

Refresher training will be provided to precinct officials by county election board personnel to ensure proper procedures are followed in the future.
