EXECUTIVE SUMMARY

INTRODUCTION

Pursuant to <u>26 O.S. § 3-130</u>, State Election Board Secretary Paul Ziriax directed five county election boards to conduct post-election manual tabulation audits of the Special Elections held on Tuesday, June 13, 2023.

The post-election audits were conducted on Wednesday, June 21 through Friday, June 23, and were open to the public. Each County Election Board posted a public notice of the date, time and location of its post-election audit at least 48 hours in advance.

The post-election audits were conducted pursuant to the procedures developed in advance under the direction of the Secretary of the State Election Board.

Post-election audits were conducted for the Special County Commissioner Elections held June 13 for the following counties: Dewey (1 precinct/General Election), Pottawatomie (1 precinct/Republican Primary), Cleveland (1 precinct/Republican Primary), McCurtain (2 precincts/Republican Primary and Democratic Primary) and Logan (mail absentee and in-person absentee/Republican Primary).

The post-election tabulation audits confirmed the certified election results, with the results from each audit matching the certified vote totals.
