EXECUTIVE SUMMARY

INTRODUCTION

Pursuant to 26 O.S. § 3-130, State Election Board Secretary Paul Ziriax directed the Comanche County Election Board to conduct a post-election manual tabulation audit of the State Senator, District 32 Special General Election held on December 12, 2023. Ziriax also directed the Oklahoma County Election Board to conduct a post-election manual tabulation audit of the State Representative, District 39 Special Primary Elections held on December 12, 2023 and the Special General Election held on February 13, 2024.

The post-election audits were conducted on Friday, February 23, 2024 and were open to the public. Each County Election Board posted a public notice of the date, time and location of its post-election audit at least 48 hours in advance.

Oklahoma County Election Board audited the following:

February 13, 2024 Special General Election (State Representative, District 39)

- Precinct 337
- Precinct 342
- Mail absentee ballots

December 12, 2023 Special Primary Election (State Representative, District 39)

- Precinct 335 (Democratic Primary)
- Precinct 369 (Republican Primary)
- Mail absentee ballots (both Republican and Democratic primaries)

The audits confirmed the results of the special general election and both special primaries, with no difference in the vote counts.

Comanche County Election Board audited the following:

December 12, 2023 Special General Election (State Senator, District 32)

- Precinct 42
- In-person absentee ("early voting") ballots

The audit confirmed the results of the special general election, with no difference in the vote counts.

The post-election audits were conducted pursuant to the procedures developed in advance under the direction of the Secretary of the State Election Board.

Participating precincts were randomly selected for the post-election audits. The post-election tabulation audits confirmed the certified election results, with the results from each audit matching the certified vote totals.
