EXECUTIVE SUMMARY

INTRODUCTION

Pursuant to <u>26 O.S. § 3-130</u>, State Election Board Secretary Paul Ziriax directed county election boards across the state to conduct post-election manual tabulation audits of the following elections:

- February 13, 2024 Elections
 - Board of Education Primary
 - Special Elections

The post-election audits were conducted Monday, May 6, 2024 through Wednesday, May 8, 2024 and were open to the public. Each County Election Board posted a public notice of the date, time and location of its post-election audit at least 48 hours in advance.

Forty (40) counties participated in the audit of the February 13, 2024 elections. Audits included the manual examination and tabulation of mail absentee ballots, in-person absentee ballots, and ballots cast on Election Day. (Participating precincts were randomly selected for the post-election audits.) Audit totals from the Board of Education Primary and Special Elections exactly matched the certified results in 39 counties. Only one minor difference was found in a school proposition election.

In Precinct 150002 in Coal County, auditors discovered a faintly marked ballot in favor of the Tupelo Public Schools proposition – resulting in the "yes" votes for the proposition being increased by one count. Auditors believe the ballot was originally read by the voting device as an "under vote." (An "under vote" occurs when the voter leaves a race/issue blank or the voting device cannot detect a mark for a race/issue.) The certified vote total was 116 votes "for the proposition." The audited total was 117 votes "for the proposition." There was no change in the vote totals "against the proposition" – with both the certified and audited votes each totaling 119. **The one vote difference did not change the outcome of the election.**

The post-election audits were conducted pursuant to the procedures developed in advance under the direction of the Secretary of the State Election Board.

The post-election tabulation audits confirmed the high level of accuracy of the certified election results for both the February 13 Board of Education Primary Election and Special Elections.
