EXECUTIVE SUMMARY

INTRODUCTION

Pursuant to <u>26 O.S. § 3-130</u>, State Election Board Secretary Paul Ziriax directed county election boards across the state to conduct post-election manual tabulation audits of the following elections:

- March 5, 2024 Elections
 - o Presidential Preferential Primary (Republican and Democratic Primaries)
 - Special Elections (propositions)

The post-election audits were conducted Monday, May 6, 2024 through Wednesday, May 8, 2024 and were open to the public. Each County Election Board posted a public notice of the date, time and location of its post-election audit at least 48 hours in advance.

All 77 counties participated in the audit of the March 5 Presidential Preferential Primary Election. Audits included the manual examination and tabulation of mail absentee ballots, in-person absentee ballots, and ballots cast on Election Day. A breakdown of the Presidential Preferential Primary audit is listed below:

Republican Primary (45* counties included)

- 39 counties audited Election Day precincts
- 4 counties audited mail absentee ballots
- 5 counties audited in-person absentee ballots ("early votes")

Democratic Primary (36* counties included)

- 28 counties audited Election Day precincts
- 4 counties audited mail absentee ballots
- 4 counties audited in-person absentee ballots ("early votes")

All audited mail absentee and in-person absentee totals exactly matched the certified results. In three precincts, a one vote difference was discovered when auditing Election Day ballots; however, these did not change the outcome of the race.

^{*}Cleveland, Oklahoma, Tulsa, and Canadian County audited both the Republican Primary and the Democratic Primary. In the Republican Primary - Cleveland, Oklahoma, and Tulsa County each audited one precinct *and* either mail or in-person absentee ballots.

In Cleveland County and Nowata County, auditors found there to be one less vote than the certified vote count. In Creek County, the audited count was one vote higher than the certified count. The table below shows the county and precinct where the minor discrepancies were found, as well as the results.

In addition to the audit of the Presidential Preferential Primary – Canadian, Dewey, Logan, McIntosh, and Major County audited local proposition elections that also appeared on the March 5 ballot. The audit included five Election Day precincts. **The audit totals exactly matched the certified results from each proposition election.**

The post-election audits were conducted pursuant to the procedures developed in advance under the direction of the Secretary of the State Election Board.

Participating precincts were randomly selected for the post-election audits. **The post-election** tabulation audits confirmed the high level of accuracy of the certified election results for both the March 5 Presidential Preferential Primary and local proposition elections.
