EXECUTIVE SUMMARY

INTRODUCTION

Pursuant to <u>26 O.S. § 3-130</u>, State Election Board Secretary Paul Ziriax directed county election boards across the state to conduct post-election manual tabulation audits of the following elections:

- April 2, 2024 Elections
 - Board of Education General Elections
 - o Special county and local elections

The post-election audits were conducted Monday, May 6, 2024 through Wednesday, May 8, 2024 and were open to the public. Each County Election Board posted a public notice of the date, time and location of its post-election audit at least 48 hours in advance.

A total of 55 counties participated in the April 2, 2024 post-election audits. All audits included the manual examination and tabulation of ballots cast on Election Day. No absentee ballots or in-person absentee ballots were audited.

The post-election audits were conducted pursuant to the procedures developed in advance under the direction of the Secretary of the State Election Board.

Participating precincts were randomly selected for the post-election audits. The post-election tabulation audits confirmed the certified election results for the April 2, 2024 Board of Education Elections and Special Elections. No discrepancies or differences in totals were reported.
