#### **EXECUTIVE SUMMARY**

#### INTRODUCTION

Pursuant to 26 O.S. § 3-130, State Election Board Secretary Paul Ziriax directed county election boards across the state to conduct a post-election manual tabulation audit of the Primary Election held on June 18, 2024.

The post-election audits were conducted Tuesday, July 16, 2024 through Thursday, July 18, 2024 and were open to the public. Each County Election Board posted a public notice of the date, time and location of its post-election audit at least 48 hours in advance.

Seventy-six (76) of the 77 counties participated in the post-election audits which consisted of federal, state, and county races – both Republican and Democratic primaries. Audits included the manual examination and tabulation of mail absentee ballots, in-person absentee ballots, and ballots cast on Election Day.

The Carter County Election Board did not participate in the post-election audit, but instead, conducted a full recount (i.e. all precincts, mail absentee ballots, and in-person absentee ballots) of the June 18 Republican Primary Election for county sheriff.

The post-election audits were conducted pursuant to the procedures developed in advance under the direction of the Secretary of the State Election Board.

Participating precincts were randomly selected for the post-election audits. The post-election tabulation audits confirmed the certified election results, with the results from each audit matching the certified vote totals exactly. No differences were found.

### **APPENDIX A**

Post-Election Recount June 18, 2024

### **BACKGROUND**

The Secretary of the State Election Board ordered the inclusion of the results of the official recount by the Carter County Election Board of the Republican Primary for Carter County Sheriff as part of the Post-Election Audit Report for the June 18 Primary Election.

### **SUMMARY**

The Carter County Election Board conducted the recount on June 28, 2024, at the request of Chris Bryant, a candidate for Carter County Sheriff. The manual recount included in-person absentee ballots, mail absentee ballots, and the ballot from all Election Day precincts. The recount confirmed the election results with no differences in the vote count. The election was settled during a public drawing, as authorized by 26 O.S. § 8-105, with candidate D.J. Long winning the election. A summary of the results can be found below:
