## **EXECUTIVE SUMMARY**

### **INTRODUCTION**

Pursuant to [26 O.S. § 3-130](#), State Election Board Secretary Paul Ziriaux directed county election boards to conduct post-election manual tabulation audits of the following candidate elections:

- February 11, 2025 Board of Education Primary Election and Special Elections
- March 4, 2025 Special Elections – including the **State Senator, District 8** Republican Special Primary Election
- April 1, 2025 Board of Education General Elections, Statutory Municipal General Elections and Special Elections – including the **State Senator, District 8** Republican Special Runoff Primary Election, **State Representative, Districts 71 and 74** Republican Special Primary Elections, and the **State Representative, District 71** Democratic Special Primary Election.
- May 13, 2025 Special Elections – including the **State Senator, District 8** General Election, and the **State Representative, Districts 71 and 74** Republican Special Runoff Primary Elections.

The post-election audits were conducted Tuesday, May 20 through Thursday, May 22, 2025 and were open to the public. Each County Election Board posted a public notice of the date, time and location of its post-election audit at least 48 hours in advance. The post-election audits were conducted pursuant to the procedures developed in advance under the direction of the Secretary of the State Election Board.

Participating counties, precincts, and races were randomly selected and included four election dates, 269 precincts, as well as both mail and in-person absentee voting, and dozens of races.

### **MANUAL TABULATION AUDIT STATISTICS**

In total, 69 county election boards participated in the audits, with some counties auditing more than one election and/or race.

All county election boards audited at least one precinct per randomly selected election. In addition, some counties also audited absentee mail ballots and in-person absentee (“early voting”) ballots. The table below shows the number of participating counties along with the type of audits conducted. All audits were conducted by manually counting the ballots and comparing them to the certified election results.

The manual post-election tabulation audit of the Whitefield Board of Education, Office 1 election revealed that one ballot in Precinct 310019 read by the voting device as a vote for candidate Royce Alverson should have been an “over vote” – meaning the voter marked more than one candidate on the ballot. If an “over vote” occurs, no candidate receives a vote for that particular office. While post-election audit results cannot be used to alter certified vote totals, **the one vote difference between the certified results and audited results for Royce Alverson would not have affected the outcome of the election.** Alverson won the election with more than 53% of the total votes.

**Election Audit:** State Senator, District 8 (Unexpired Term) Republican Special Primary

**County:** Okmulgee

**Audit Date:** May 21, 2025

During the manual post-election tabulation audit of the State Senator, District 8 (unexpired term) Republican Special Primary in Okmulgee County, auditors discovered three ballots in Precinct 560029 that were not included in the vote totals. Those ballots reflected one vote each for candidates Steven Baldridge, Bryan Logan, and Hoss Durrett.

After finding the three ballots, the Secretary of the County Election Board compared the Tally Detail Tape (printed from the voting device on election night) to the Certification Report and Voter History Credit Report – confirming that the certified results were accurate.

The Secretary of the County Election Board believes the three ballots were actually “spoiled” ballots that were mistakenly placed in the ballot transfer case instead of being placed in the Spoiled and Discarded Ballot Bag, according to proper procedure. The election officials in Precinct 560029 were newly appointed precinct officials, and will be provided additional training to ensure proper procedure is followed during future elections.

**Election Audit:** Town of Fairfax, Board of Trustees

**County:** Osage

**Audit Date:** May 21, 2025

The manual post-election tabulation audit of the Town of Fairfax Board of Trustees election confirmed the election results with no differences between the audited vote count for each candidate and the certified vote count for each candidate. However, in Precinct 570301, auditors found one less “under vote” than what was previously recorded. Instead of 48 “under votes,” auditors found only 47. (An “under vote” occurs when a voter does not participate in a race or election by not marking a selection.)

The Secretary of the County Election Board compared the Tally Detail Tape (printed from the voting device on election night) to the Certification Report and the total number of ballots found in the Ballot Transfer Box. The Secretary confirmed that the number of ballots cast, according to the Tally Detail Tape and Certification Report, matched the number of ballots securely stored in the Ballot Transfer Box.

The Secretary directed auditors to count the ballots four times to confirm their findings. While audit results cannot be used to change certified election results, **the discovery of the one additional “under vote” would have had no impact on the election results.**
