EXECUTIVE SUMMARY

INTRODUCTION

Pursuant to [26 O.S. § 3-130](#), State Election Board Secretary Paul Ziriaux directed thirty-three (33) counties to conduct post-election manual tabulation audits of the following elections:

- State House of Representatives, District 35 Special Republican Primary Election held on December 9, 2025
- State House of Representatives, District 35 Special Republican Runoff Primary Election held on January 13, 2026
- State House of Representatives, District 35 Special General Election held on February 10, 2026
- Board of Education Primary Election and Special Elections held on February 10, 2026.

The post-election audits were conducted on Tuesday, March 2, 2026 and Wednesday, March 3, 2026 and were open to the public. Each County Election Board posted a public notice of the date, time and location of its post-election audit at least 48 hours in advance.

All post-election audits were conducted pursuant to the procedures developed in advance under the direction of the Secretary of the State Election Board.

December 9 Election

Five counties – Creek, Noble, Osage, Pawnee, and Payne – conducted post-election audits of the December 9 State House of Representatives, District 35 Special Republican Primary Election.

Mail absentee ballots, early voting ballots, and five precincts were audited. Participating precincts were randomly selected for the post-election audits. The post-election tabulation audits for Creek, Noble, Osage, and Payne County confirmed the certified election results, with the results from each audit matching the certified vote totals in all counties. In Pawnee County, one additional ballot was discovered when the secured transfer case was opened to conduct the audit. Details can be found in the Additional Findings section of this report.

January 13 Election

Five counties – Creek, Noble, Osage, Pawnee, and Payne – conducted post-election audits of the January 13 State House of Representatives, District 35 Special Republican Runoff Primary Election.

Mail absentee ballots, early voting ballots, and five precincts were audited. Participating precincts were randomly selected for the post-election audits. The post-election tabulation audits for all five counties confirmed the certified election results, with the results from each audit matching the certified vote totals in all counties.

February 10 Election

Thirty-three (33) counties conducted post-election audits of the February 10 election. All 33 counties conducted audits of at least one precinct, while sixteen (16) counties conducted additional audits of mail and/or in-person absentee (“early voting”) ballots. The audits consisted of Board of Education and municipal candidate elections. Additionally, five counties – Creek, Nowata, Osage, Pawnee, and Payne – conducted audits of the State House of Representatives, District 35 Special General Election, which consisted of a limited examination of Election Day ballots, mail absentee ballots, and in-person absentee (“early voting”) ballots. Participating precincts were randomly selected for the post-election audits.

Board of Education and Municipal Elections

The post-election tabulation audits confirmed the certified election results for the Board of Education and municipal elections, with the results from each audit matching the certified vote totals in all counties.

State House of Representatives, District 35 Special General Election

The post-election tabulation audits confirmed the certified election results for the State House of Representatives, District 35 Special General Election in Creek, Nowata, Osage, and Payne County, with the results from each audit matching the certified vote totals in all counties. In Pawnee County, one additional ballot was discovered when the secured transfer case was opened to conduct the audit. Details can be found in the Additional Findings section of this report.

In Pawnee County, one additional ballot was discovered in the secured transfer case when it was opened for the manual post-election audit. After counting the ballots and tallying the votes, it is believed that the unscanned ballot was likely a spoiled ballot that was mistakenly placed inside the ballot box, instead of the spoiled ballot bag, according to precinct official instructions and election protocol. The additional vote had no impact on the outcome of the election. Additional training will be provided to precinct officials.

Election Audit: State House of Representatives, District 35 Special General Election

County: Pawnee

Audit Date: 3/2/2026

In Pawnee County, one additional ballot was discovered in the secured transfer case when it was opened for the manual post-election audit. After counting the ballots and tallying the votes, it is believed that the unscanned ballot was related to a voting device issue earlier in the day, when a ballot became jammed in the document feeder while a voter was trying to cast a ballot.

A precinct official attempted to remove the ballot, so that it could be reinserted into the device. However, after multiple attempts, it was determined that the ballot could not be safely removed without damaging the ballot.

Following precinct official instructions and Election Day protocol, a precinct official was able to successfully reboot the device, clearing the jam. Due to the fact that the ballot was partially inserted into the device when the jam was cleared, it is believed that the device may have failed to read the ballot. In general, voting device jams are rare and are typically the result of a ballot being inserted incorrectly or too aggressively.

The extra ballot, which was cast on Election Day in Precinct 590118, resulted in one additional vote for Dillion Travis – bringing the vote total from 188 to 189. The additional vote had no impact on the outcome of the election.
