EXECUTIVE SUMMARY

INTRODUCTION

Pursuant to [26 O.S. § 3-130](#), State Election Board Secretary Paul Ziriaux directed all seventy-seven (77) counties to conduct post-election manual tabulation audits of the following elections:

- Statewide primary elections held on June 16, 2026
- State Senator, District 17 Special Republican Primary Election held on June 16, 2026
- State Question 832 Special Election held on June 16, 2026

The post-election audits were conducted on Monday, July 13, 2026 through Wednesday, July 15, 2026 and were open to the public. Each county election board posted a public notice of the date, time and location of its post-election audit at least 48 hours in advance.

All post-election audits were conducted pursuant to the procedures developed in advance under the direction of the Secretary of the State Election Board.

Statewide Primary Election

Numerous federal, state, and county officer elections – a combination of both Republican and Democratic primaries – were audited across the state. The audits included elections for the following offices:

U.S. Senator – Democratic Primary

U.S. Representative – Districts 3, 4, and 5 – Democratic Primaries

Governor – Democratic Primary and Republican Primary

Lieutenant Governor – Republican Primary

Attorney General – Republican Primary

Corporation Commissioner – Republican Primary

State Representative – Districts 1, 6, 18, 19, 24, and 38 – Republican Primaries

State Senators – Districts 2, 4, 10, 12, 18, 20, 26, 28, 32, 36, and 38 – Republican Primaries

One district attorney election (Republican Primary), one district judge election, and two associate district judge elections were also included in the audits.

Five counties - Grant, Carter, Garvin, Stephens, and Washington County – audited primary elections for county assessor.

Sixteen (16) counties - Major, Cimarron, Cotton, Ellis, Harper, Jefferson, Johnston, Love, McClain, McIntosh, Marshall, Okfuskee, Ottawa, Roger Mills, Texas, and Woodward County – audited primary

elections for county commissioner.

Two counties – Grady and Haskell County – audited primary elections for county treasurer.

In accordance with state law, the audits consisted of Election Day, mail absentee, and/or in-person absentee (“early voting”) ballots which were manually examined and compared to the certified results. Participating precincts were randomly selected for the audits.¹

The post-election manual tabulation results from each audit confirmed the certified election results, with the results from each audit matching the certified vote totals in all counties for all offices, with the exception of the Republican Primary for Lieutenant Governor in McCurtain County. Details can be found in the Additional Findings section of this report.

State Senator, District 17 Special Republican Primary Election (unexpired term)

Three counties – Cleveland, Oklahoma, and Pottawatomie County – conducted post-election audits of the State Senator, District 17 Special Republican Primary Election. Three precincts (one in each county) were randomly selected for the audit.

In accordance with state law, the audits consisted of a limited examination of Election Day ballots cast in three precincts, which were manually examined and compared to the certified results. Participating precincts were randomly selected for the post-election audits.

The post-election manual tabulation audits for all three counties confirmed the certified election results, with the results from each audit matching the certified vote totals in all counties.

State Question 832 Special Election

Six counties conducted post-election audits of the election for State Question 832. Six precincts (one in each county) were randomly selected for the audit.

In accordance with state law, the audits consisted of a limited examination of Election Day ballots cast in each of the six precincts, which were manually examined and compared to the certified results. Participating precincts were randomly selected for the post-election audits.

The post-election manual tabulation audits for all six counties confirmed the certified election results, with the results from each audit matching the certified vote totals in all counties.

¹ Precinct 120101 in Choctaw County was originally scheduled to audit the Republican Primary for Governor; however, this precinct could not be audited due to clerical errors (which did not affect the outcome of the election) on the part of precinct officials. Precinct 120210 was randomly selected to be audited in its place for the same race.

In McCurtain County, the manual post-election audit of Precinct 450008 resulted in one less vote than the certified election results for candidate David Ostrowe in the Republican Primary for Lieutenant Governor – bringing the candidate’s votes from 20 to 19.

Following an election, ballots are secured in a transfer case that is sealed and signed by all three precinct officials before being taken into custody by the county sheriff. However, it appears precinct officials failed to secure one of the counted ballots in the transfer case, as required. The difference had no impact on the outcome on the election.

Remedial training will be provided to precinct officials by the County Election Board Secretary.
