## 2024: Limited Committees and Unlimited Committees Registration & Reporting

- **Quarterly reports are required\***. Additional reports may be required if the committee makes \$5,000 or more of Independent Expenditures or Electioneering Communications prior to an election (see below).
- **NOTE:** State Question Committees will use the Unlimited State Question Committee Calendar instead of this calendar.
