2026: State Political Party Committee Reporting

Local Party Committees: County, congressional district and other non-state committees will use the local party committee calendar.

All state party committees will file reports on a quarterly basis and pay the registration/renewal fee annually in July. State political party committees will file a current Statement of Organization in July of odd-numbered years. During election years, if the committee makes independent expenditures and electioneering communications, the committee may also need to file pre-election reports detailing independent expenditures and electioneering communications.

2026 Special Election HD 92 and SD 17 Independent Expenditure (IE) & Electioneering Communications (EC) Reporting

Committees that expend a total of \$5,000 or more on independent expenditures or electioneering communications must file pre-election reports detailing the expenditures according to the calendar below.

INDEPENDENT EXPENDITURES & ELECTIONEERING COMMUNICATIONS REPORTS	
The reports below will be triggered when making Independent Expenditures or Electioneering Communications of \$5,000 or more in the aggregate prior to an election.*Once the \$5,000 threshold is met during a pre-election reporting period, all additional IEs/ECs must be reported regardless of the amount.

April 1 – June 1, 2026	June 2 – June 8, 2026
June 2 – June 16, 2026	Next business day reporting required when making IE/ECs of \$5,000 or more in the aggregate during this period (*See above)
JUNE 16, 2026 - PRIMARY ELECTION	
June 17 – August 10, 2026	August 11 – August 17, 2026
August 11 – August 25, 2026	Next business day reporting required when making IE/ECs of \$5,000 or more in the aggregate during this period (*See above)
AUGUST 25, 2026 - RUNOFF PRIMARY ELECTION	
August 26 – October 19, 2026	October 20 – October 26, 2026
October 20 – November 3, 2026	Next business day reporting required when making IE/ECs of \$5,000 or more in the aggregate during this period (*See above)
NOVEMBER 3, 2026 - GENERAL ELECTION
