Categories of Licensing and License Fees:

1. Portable Fire Extinguisher: Company - \$250.00
 - a. Company Qualified Agent - \$200.00
 - b. Technician - \$75.00
 - c. Salesperson - \$75.00
 - d. Trainee - \$75.00
2. Pre-Engineered Kitchen Fire Suppression Systems: Company – \$250.00
 - a. Company Qualified Agent - \$200.00
 - b. Technician - \$75.00
 - c. Salesperson - \$75.00
 - d. Trainee - \$75.00
3. Pre-Engineered Industrial Fire Suppression Systems: Company - \$250.00
 - a. Company Qualified Agent - \$200.00
 - b. Technician - \$75.00
 - c. Salesperson - \$75.00
 - d. Trainee - \$75.00
4. Engineered Fire Suppression Systems: Company - \$250.00
 - a. Company Qualified Agent - \$200.00 - Must provide NICET III in Special Hazards
 - b. Designer - \$100.00
 - c. Technician - \$75.00 - Must provide NICET II in Special Hazards
 - d. Salesperson - \$75.00 - Must provide NICET I
 - e. Trainee - \$75.00

Renewal fees:

- a. Company License - \$250.00
- b. Company Qualified Agent - \$100.00
- c. Designer - \$100.00
- d. Technician - \$35.00
- e. Salesperson - \$35.00
- f. Trainee - \$35.00
- g. Duplicate license - \$25.00

License Period:

1. License shall expire one (1) year after the original licensing and each year thereafter
2. Can renew an expired license by paying **double** the renewal fee
3. Cannot renew if license has been expired for two (2) years or more
 - a. Must reapply and test

Testing:

Everyone must take a State test except Trainee applicants.

- a. Go to the nearest Oklahoma Career Tech (vo-tech) to test.

NICET Levels that must provide documentation:

Engineered Fire Suppression Systems:

- i. Q.A. - must have NICET level III:
- ii. Designer
- iii. Technician - must have NICET level II
- iv. Salesperson - must have NICET level I

Applications for Licensing:

1. Can be found on the State Fire Marshal's website
 - a. <http://www.ok.gov/fire/>
2. Fill out Initial Application completely and mail to the OKSFM with supporting documentation:
 - a. Two (2) fingerprint cards;
 - b. Verification of technical experience (for Qualified Agent applicants only),
 - c. Current ICC-NAFED and/or current NICET certificate(s)
 - d. Passing test scores. Test scores are valid for 90 days and application must be submitted 90 days from taking the test or the test must be retaken. If a passing score is not achieved on the second attempt, the applicant must wait thirty (30) days before testing again; and
 - e. Applicable licensing fees
3. After application has been approved, OKSFM will mail the license to you.
