Instructions and Procedures for Final Inspections

1. OPEN, READ and VERIFY approved plans and that you have addressed all plan review comments/callouts on approved plans and or items noted by the OKSFM Field Agent prior to requesting your inspection(s).
2. Please contact the OKSFM a minimum of 7 days in advance to request inspections. Once the inspection is logged and assigned to an OKSFM Agent, an Agent will contact you within 7-10 business days for scheduling and further instructions.
3. VERIFY all OKSFM approved plans and permits are on-site at final inspection. Failure to comply will result in a FAILED inspection.
4. COMPLETE the **Certificate of Completion – Final Statement of Compliance Form** that is available on the OKSFM website or available from an OKSFM Agent. The form may be legibly filled in by hand or may be downloaded on-line/fillable form for printing and final signatures. This form is now used in lieu of previous final contractor statement of compliance letters (foundation, structural, and MEP) unless otherwise noted by the OKSFM and agents performing inspections.
 - a. If the project was designed and plans sealed by a registered design professional such as an Architect or Engineer, then the ARCHITECT and or ENGINEER will be responsible for completing the form and obtaining the required signatures regardless if the project was exempt from an architect or engineer.
 - b. If the project was not designed or sealed by a registered design professional, then the OWNER is responsible for completing the form and obtaining the required signatures from each contractor.
 - c. A final inspection report and or a Certificate of Occupancy will not be issued without this form being completed in its entirety. If this form is not on-site at the final inspection, the inspection will be FAILED.
 - d. NOTE: The **Certificate of Completion-Final Statement of Compliance Form** is **NOT** a Certificate of Occupancy
 - e. **ATTN: ARCHITECTS/ENGINEERS**, by completing this form you are not attesting to the work performed by general contractors or licensed contractors where applicable. You are attesting that you have verified the project is constructed as per your design and or required periodic inspections.

Did your building project include a deferred submittal permit or standalone submittal such as a fire sprinkler, fire alarm, access control, carbon dioxide, etc.? If yes, see below:

1. The **Certificate of Completion – Final Statement of Compliance Form** is required in addition to all required documentation and or acceptance test forms, on site, at the final inspection as applicable to the project and trade. If required documentation is not on-site at the final inspection, the inspection will be FAILED.
 - a. Monitoring Agreement and Record of Completion/Acceptance Test (Fire Alarm)
 - b. Hood Suppression Acceptance Test Certificate (Kitchen Hood Suppression)
 - c. Alternative Suppression Record of Completion/Acceptance Test (Clean Agents, etc.)
 - d. Access Control Record of Completion Letter from installing company
 - e. Carbon Dioxide (CO2) Record of Completion Letter from installing company
 - f. Underground Flush, Record of Completion, Hydrostatic Test Certificates, FDC/Fire Chief Letter (Fire Sprinkler)
 - g. Smoke Control Record of Completion/Engineers Acceptance Test Report
 - h. Approved/Stamped Plans and Permit(s)

OBSERVATION OF CONSTRUCTION – STATEMENT OF COMPLIANCE

- A. For a building or structure which by law may only be constructed with plans prepared and sealed by an Oklahoma licensed architect and or engineer in accordance with the requirements set forth for such registered design professionals, it shall be the duty of the registered design professional in responsible charge or owner of such a structure to provide for periodic observation of the construction of the structure to determine if the work is proceeding in accordance with the plans and specifications as approved by the State Fire Marshal. The observations shall be performed by an Oklahoma registered architect and or an Oklahoma registered engineer as applicable to said project and where required.
- B. Upon completion of such work, where the law or rules required the project to be designed and sealed in accordance with the requirements set forth by the Oklahoma Board of Architects and or Oklahoma Board of Engineers thus requiring the owner to engage an architect or registered engineer, the owner shall furnish to the State Fire Marshal this certificate signed by the registered design professional of record stating that the periodic observations have been made and that to the best of the architect's or engineer's knowledge, information and belief, all work was completed in accordance with those codes, fire safety standards and regulations stipulated in the plans and specifications previously approved by the State Fire Marshal. **Review by the Oklahoma State Fire Marshal's Office shall not relieve the applicant of the responsibility of compliance with all applicable codes and standards.** When the owner has not engaged an architect or registered engineer, and the same is not required by law or by the Oklahoma Architectural and or Oklahoma Engineering Act(s) and or rules, the owner must submit this certificate of completion when appropriate, but always under his signature.
- C. Occupancy or use of a building or structure prior to furnishing this form to the State Fire Marshal as required under his regulation is expressly forbidden by the State Fire Marshal, unless and until a satisfactory inspection has been made by the State Fire Marshal or his certified representative.
- D. In order to comply with OKSFM requirements and before a Certificate of Occupancy is issued, this completed form shall be submitted to the State Fire Marshal Agent at final inspection. This is to be completed by the architect, engineer, or, if neither is required by law, the owner.
