## There was no New Business

Executive Director's Report- Agency Financial update- Mr. Stiles reported gross receipts for August 2022 to be \$13,447.50 with \$980.75 going to the State of Oklahoma general fund. The expenses for the same timeframe totaled \$23,390.67 and net income after expenses totaled -\$10,923.92

No vote was taken on the following statute or rule changes: Change of the age requirement for licensure in statute; change of the age and education requirement for apprenticeship in statute; removal of the additional education requirement in Board Rule, OAC 235:10-3-1(5)(B) and (6).

Public Comment limited to 2 minutes per person and limited to proposed statute or rule changes- Mr. Roberts asked Board staff to compile a list of all recommendations regarding statute or rule changes. The list will be sent to Board members and members will rank the recommendations by priority. If these changes are not made this year, the list will be used for next year. The list that was discussed was:

Age requirement changes

Crematory operator license

60-mile limit from residence to location for FDIC

Disclosures: sub-contractors

Require certain disclosures be made via telephone, in person, in writing & online

Additional prohibitions on commercial embalming establishments Require license verification for intrastate & interstate trade calls Require use of cremation container Require all-inclusive pricing for direct cremation

Administrative penalties & sanctions schedule
