Assistants can meet with families and work services but cannot embalm. They are tied to a licensee and if the assistant violates Board rules/statutes, then the licensee and the FDIC both get in trouble by the Board. In Kansas, the assistant only needs to take a law exam and does not need any mortuary school.

International Conference National Exam Statistics Update -Mr. Stiles reported that The International Conference provided statistics for the National Exams. Between January 1, 2023 and June 30, 2023, the pass rate for first time takers for the Arts Exam was 79% and 68% for the Science Exam. UCO was 71% pass rate for the Arts and 60% for the Science Exam for first time takers


Licensing Statistics Update -Mr. Stiles reported that in 2017, there were 86 apprentices, 1012 embalmers, and 1067 funeral directors. Prior to the August 2023 meeting, there were 137 apprentices, 1008 embalmers, and 1083 funeral directors. The biggest age range for apprentices is between 21-30 with 64 apprentices in that range. The biggest age ranges for funeral director and embalmers are between 51-60.

# COMPLAINT AND NOTICE OF HEARING

The State of Oklahoma, ex rel., Oklahoma Funeral Board ("Board"), by and through Assistant Attorney General Kylie Cooper, files this Complaint and Notice of Hearing, alleging that the Respondents, MICHAEL'S FUNERAL HOME, MICHAEL'S FUNERAL HOME INC., and MICHAEL DAVIS, have violated provisions of the State Funeral Services Licensing Act, 59 O.S. § 395.1 et seq. (the "Act"), and Rules of the Board, Oklahoma Administrative Code ("O.A.C.") Section 235:10-1-1 et seq. (the "Rules"), in the manner set forth below:

- 8. By public vote during the meeting on July 13, 2023, the Board found probable cause to file a formal complaint against Respondents for the violations alleged herein.
- 9. The prosecution has sufficient evidence which, if presented to the Board at an evidentiary hearing, would constitute clear and convincing evidence of the alleged violations.

### ALLEGED CONCLUSIONS OF LAW

- 10. Respondents violated O.A.C. 235:10-7-2(5) by failing to comply with the requirements of the Oklahoma Statutes and Rules of the State Insurance Commission pertaining to pre-need funeral service arrangements.
- 11. FDIC is "responsible for the legal and ethical operation of the [Funeral Home] and is accountable to the Board." 59 O.S. § 396.2(12). Therefore, Respondent Michael Davis, as the Funeral Director in Charge of the Funeral Home is also liable for the above violations.
- 12. Due to the above violations, Respondents are subject to disciplinary action by the Board. See 59 O.S. §§ 396.2a(9) and (11); id. at §§ 396.12c(A)(5) and (8); id. at § 396.12d; id. at § 396.12e.

#### **AUTHORIZED PENALTIES**

13. The Board is authorized to impose any of the following penalties for violations of the Act or Rules: (1) denial, revocation, suspension, or nonrenewal of license or certificate of apprenticeship; (2) administrative fines up to ten thousand dollars (\$10,000.00) per series of related violations<sup>1</sup>; (3) injunctive proceedings; and (4) other disciplinary action, 59 O.S. §§ 396.12c(5) and (8); *id.* at § 396.12c; *id.* at § 396.12d; *id.* at § 396.12e.

When determining the amount of an administrative penalty, the Board shall consider, but not be limited to:

14. Further, the Board is authorized to "impose . . . as a condition of any adverse disciplinary action, the payment of costs expended by the Board in investigating and prosecuting the violation." 59 O.S. § 396.12e(B). Costs may include, but are not limited to, "staff time, salary and travel expenses, [and] witness fees and attorney fees." *Id*.

CONDITIONAL ADMINISTRATIVE ORDER
AND NOTICE OF RIGHT TO BE HEARD
OKLAHOMA FUNERAL BOARD

COMES NOW the State of Oklahoma, ex rel. Glen Mulready, Insurance Commissioner, by and through counsel, Antuanya "Bo" DeBose, and alleges and states as follows:

# **JURISDICTION**

- 1. Glen Mulready is the Insurance Commissioner of the State of Oklahoma and, as such, is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code, 36 O.S. §§ 101-7401, and the Prepaid Funeral Benefits Act 36 O.S. §§ 6121-6136.18.
- 2. Michael's Funeral Home, Inc ("Respondent") is a permitted provider of Prepaid Funeral Benefit contracts in the state of Oklahoma and holds permit number 863294. Respondent's address of record is 501 West Broadway Street, Drumright, Oklahoma 74030.
- 3. The Insurance Commissioner has jurisdiction over the subject matter raised in this dispute and may issue penalties pursuant to 36 O.S. §§ 6123 and 6130.
- 4. Pursuant to 36 O.S. § 6130(B) the Insurance Commissioner may censure, suspend, or revoke a prepaid funeral permit or impose a fine in the amount of \$100.00 to \$1,000.00 or impose both such punishment and fine, for violating any provision of the Prepaid Funeral Benefits Act.



5. If Respondent requests a hearing in writing in this matter, pursuant to OAC 365:1-7-1, the Insurance Commissioner will appoint an independent hearing examiner who shall sit as a quasi-judicial officer and preside over the hearing requested by Respondent.

### FINDINGS OF FACT

- 6. Pursuant to 36 O.S §6125(K), "No organization holding a permit issued pursuant to the provisions of Sections 6121 and 6124 of this title shall accept any funds except pursuant to the provisions of a contract for prepald funeral or burial benefits authorized by the provisions of Sections 6121 through 6136.18 of this title, and no organization shall accept funds from a purchaser in excess of the contracted price of prepaid funeral or burial benefits purchased."
- 7. Pursuant to 36 O.S §6128, "Each organization shall file an annual report with the Insurance Commissioner on or before March 15 of each year in such form as the Insurance Commissioner may require, showing the names and addresses of all persons with whom contracts for prepaid funeral benefits have been made prior to December 31 of the preceding year which had not been fully discharged on December 31 and, also showing the date of the contract, the name of the bank or depository holding the trust fund and the amount of the trust fund under each contract on the preceding December 31."
- 8. Respondent filed its 2021 annual report on or about March 15, 2022.
- 9. Respondent's 2021 annual report shows one (1) contract holder has a lower contract amount than the amount of principal collected and deposited on the PF-1-c.
- 10. Respondent's 2021 annual report is missing a signed PF-3 with the printed name of the officer and CPA. Additionally, Respondent's 2021 annual report is missing Schedule(s) 3 and 6.

- 11. On or about October 19, 2022, the Oklahoma Insurance Department's Financial division ("Financial") emailed Respondent and requested a corrected PF-1-c or an explanation of the variances, along with the missing signed PF-3, Schedule 3 and Schedule 6.
- 12. The Respondent has failed to file a corrected PF-1-c or the missing items with Financial.

### CONCLUSIONS OF LAW

- 13. Respondent has violated 36 O.S. §6125(K) by accepting funds from one (1) contract holders in excess of the contracted price of prepaid funeral or burial benefits purchased.
- 14. Respondent has violated 36 O.S. §6128 and 36 O.S. §6129.1 by failing to file the PF-3, Schedule 3 and Schedule 6 missing from its 2021 annual report.



# **COMPLAINT AND NOTICE OF HEARING**

The State of Oklahoma, ex rel., Oklahoma Funeral Board ("Board"), by and through Assistant Attorney General Kylie Cooper, files this Complaint and Notice of Hearing, alleging that the Respondents, YANDA AND SON FUNERAL HOME & CREMATION SERVICES, YANDA AND SON FUNERAL HOME & CREMATION SERVICES INC., and DONNA YANDA, have violated provisions of the State Funeral Services Licensing Act, 59 O.S. § 395.1 et

seq. (the "Act"), and Rules of the Board, Oklahoma Administrative Code ("O.A.C.") Section 235:10-1-1 et seq. (the "Rules"), in the manner set forth below:

# **JURISDICTION**

- 1. Respondent YANDA AND SON FUNERAL HOME & CREMATION SERVICES ("Funeral Home") is licensed by the Board, establishment license number 1330ES, and is located at 1500 W Vandament, Yukon, OK 73099.
- 2. Respondent DONNA YANDA ("Funeral Director in Charge" or "FDIC") is licensed by the Board as a funeral director, license number 3284FD and at all relevant times was the Funeral Director in Charge at Funeral Home.
- 3. Respondent YANDA AND SON FUNERAL HOME & CREMATION SERVICES, INC. ("Owner") is, and at all relevant times was, the owner of record for Funeral Home. Upon information and belief, Respondent DONNA YANDA is the owner and registered agent for Respondent YANDA AND SON FUNERAL HOME & CREMATION SERVICES, INC.
- 4. The Board has jurisdiction over Respondents pursuant to 59 O.S. §§ 396.2a(9) and (11). See also 59 O.S. § 396.12f(F).

## **FACTUAL ALLEGATIONS**

5. On or about May 15, 2023, Board staff received an Amended Conditional Administrative Order in State of Oklahoma, ex re. Glen Mulready v. Yanda and Son Funeral Home & Cremation Services, Inc., Case No. 20-0385-DIS (Exhibit "A"). This Order alleged that Yanda and Son Funeral Home & Cremation Services failed to obtain approval from the Insurance Commissioner before converting trust-funded prepaid funeral benefits to insurance-funded prepaid funeral benefits, in violation of 36 O.S. § 6136.18.

- 6. On May 18, 2023, Board staff filed a complaint with the Board, alleging that Respondents were in violation of O.A.C. 235:10-7-2(5) by failing to comply with the requirements of the Oklahoma Statutes and Rules of the State Insurance Commission. The Board provided Respondents with the Notice of Complaint via certified mail.
- 7. On May 31, 2023, Respondents filed their response to Complaint 23-57 with the Board. Respondents stated that they paid the fine and have resolved all issues with the Insurance Department.
- 8. By public vote during the meeting on July 13, 2023, the Board found probable cause to file a formal complaint against Respondents for the violations alleged herein.
- 9. The prosecution has sufficient evidence which, if presented to the Board at an evidentiary hearing, would constitute clear and convincing evidence of the alleged violations.

## ALLEGED CONCLUSIONS OF LAW

- 10. Respondents violated O.A.C. 235:10-7-2(5) by failing to comply with the requirements of the Oklahoma Statutes and Rules of the State Insurance Commission pertaining to pre-need funeral service arrangements.
- 11. FDIC is "responsible for the legal and ethical operation of the [Funeral Home] and is accountable to the Board." 59 O.S. § 396.2(12). Therefore, Respondent Donna Yanda, as the Funeral Director in Charge of the Funeral Home is also liable for the above violations.
- 12. Due to the above violations, Respondents are subject to disciplinary action by the Board. See 59 O.S. §§ 396.2a(9) and (11); id. at §§ 396.12c(A)(5) and (8); id. at § 396.12d; id. at § 396.12e.

# **AUTHORIZED PENALTIES**

13. The Board is authorized to impose any of the following penalties for violations of the Act or Rules: (1) denial, revocation, suspension, or nonrenewal of license or certificate of apprenticeship; (2) administrative fines up to ten thousand dollars (\$10,000.00) per series of related violations<sup>1</sup>; (3) injunctive proceedings; and (4) other disciplinary action. 59 O.S. §§ 396.12c(5) and (8); *id.* at § 396.12c; *id.* at § 396.12d; *id.* at § 396.12e.

14. Further, the Board is authorized to "impose . . . as a condition of any adverse disciplinary action, the payment of costs expended by the Board in investigating and prosecuting the violation." 59 O.S. § 396.12e(B). Costs may include, but are not limited to, "staff time, salary and travel expenses, [and] witness fees and attorney fees." *Id*.

# AMENDED CONDITIONAL ADMINISTRATIVE ORDER AND NOTICE OF RIGHT TO BE HEARD

COMES NOW the State of Oklahoma, ex rel. Glen Mulready, Insurance Commissioner, by and through his attorney, Teresa L. Green, and alleges and states as follows:

## **JURISDICTION**

- 1. Glen Mulrendy is the Insurance Commissioner of the State of Oklahoma and is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code, 36 O.S. §§ 101 et seq., including Prepaid Funeral Services and Funeral Service Merchandise Act, 36 O.S. §§ 6121 et seq.
- 2. Yanda & Son Funeral Home & Cremation Services, Inc. ("Respondent") is a prepaid funeral benefit permit holder in the State of Oklahoma, permit number 863007. Its mailing address of record is P.O. Box 850119, Yukon, OK 73085-0119.
- 3. The Insurance Commissioner may censure, suspend or revoke, and/or may fine any permit holder who violates any provision of the Prepaid Funeral Services and Funeral Services



Merchandise Act a civil penalty of not less than \$100.00 and not more than \$1,000.00, See 36 O.S. \$ 6130(B).

## FINDINGS OF FACT

- 4. Pursuant to 36 O.S. § 6136.18, the Insurance Commissioner shall approve a conversion from trust-funded prepaid funeral benefits to insurance-funded prepaid funeral benefits as safeguarding the rights and interests of the individual who purchases the prepaid funeral benefits contract.
  - 5. Respondent's 2018 Annual Report names four (4) contracts on the PF-1-c.
  - 6. Respondent's 2019 Annual Report names zero (0) contracts on the PF-1-c.
- 7. The total monies held in trust reported by Respondent on the 2018 and 2019 Annual Reports does not match.
- 8. Respondent explained to the Oklahoma Insurance Department that the change is due to converting the trust backed contracts into insurance backed contracts.
- 9. Respondent at no time has obtained approval from the Oklahoma Insurance Department to convert the trust-funded prepaid funeral benefits to insurance-funded prepaid funeral benefits for any of the four (4) contracts reported on the 2018 Annual Report on the PF-1-c.

### **CONCLUSIONS OF LAW**

10. Respondent violated 36 O.S. § 6136.18 by failing to obtain approval from the Insurance Commissioner for conversion from trust-funded prepaid funeral benefits to insurance-funded prepaid funeral benefits when Respondent converted four (4) contracts between filing the 2018 Annual Report and filing the 2019 Annual Report from trust backed to insurance backed contracts.


# **ORDER**

- 7. On May 31, 2023, Respondents filed their response to Complaint 23-59 with the Board. Respondents stated that they paid the fine and have resolved all issues with the Insurance Department.
- 8. By public vote during the meeting on July 13, 2023, the Board found probable cause to file a formal complaint against Respondents for the violations alleged herein.
- 9. The prosecution has sufficient evidence which, if presented to the Board at an evidentiary hearing, would constitute clear and convincing evidence of the alleged violations.

#### ALLEGED CONCLUSIONS OF LAW

- 10. Respondents violated O.A.C. 235:10-7-2(5) by failing to comply with the requirements of the Oklahoma Statutes and Rules of the State Insurance Commission pertaining to pre-need funeral service arrangements.
- 11. FDIC is "responsible for the legal and ethical operation of the [Funeral Home] and is accountable to the Board." 59 O.S. § 396.2(12). Therefore, Respondent Donna Yanda, as the Funeral Director in Charge of the Funeral Home is also liable for the above violations.
- 12. Due to the above violations, Respondents are subject to disciplinary action by the Board. See 59 O.S. §§ 396.2a(9) and (11); id. at §§ 396.12c(A)(5) and (8); id. at § 396.12d; id. at § 396.12e.

#### **AUTHORIZED PENALTIES**

13. The Board is authorized to impose any of the following penalties for violations of the Act or Rules: (1) denial, revocation, suspension, or nonrenewal of license or certificate of apprenticeship; (2) administrative fines up to ten thousand dollars (\$10,000.00) per series of related violations<sup>1</sup>; (3) injunctive proceedings; and (4) other disciplinary action. 59 O.S. §§ 396.12c(5) and (8); *id.* at § 396.12c; *id.* at § 396.12d; *id.* at § 396.12e.

14. Further, the Board is authorized to "impose... as a condition of any adverse disciplinary action, the payment of costs expended by the Board in investigating and prosecuting the violation." 59 O.S. § 396.12e(B). Costs may include, but are not limited to, "staff time, salary and travel expenses, [and] witness fees and attorney fees." *Id*.

15. In lieu of prosecution, Respondents "may elect to surrender the license." *Id.* at § 396.12e(D). However, should Respondents surrender their licenses, they "shall be forever barred from obtaining a reissuance of said license or certificate of apprenticeship." *Id.* 

#### NOTICE OF HEARING

An EVIDENTARY HEARING will be held before the Board on SEPTEMBER 14, 2023 at 10:00 A.M. Respondents may appear personally or through an attorney. If Respondents fail to appear, the hearing will be held in their absence. Respondents have the right to submit a written response, cross-examine witnesses, and present evidence on their behalf. See 75 O.S. §§ 309 and 310. If the Board decides, after considering all the evidence presented, that Respondents are in

the nature, circumstances and gravity of the violation and, with respect to the person or entity found to have committed the violation, the degree of culpability, the effect on ability of the person or entity to continue to do business and any show of good faith in attempting to achieve compliance with the provisions of the Funeral Services Licensing Act.

violation of any of the above-referenced laws, the Board may take any authorized disciplinary action it deems appropriate.

COMES NOW the State of Oklahoma, ex rel. Glen Mulready, Insurance Commissioner, by and through counsel, Antuanya "Bo" DeBose, and alleges and states as follows:

#### **JURISDICTION**

- 1. Glen Mulready is the Insurance Commissioner of the State of Oklahoma and, as such, is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code, 36 O.S. §§ 101-7401, and the Prepaid Funeral Benefits Act 36 O.S. §§ 6121-6136.18.
- 2. Yanda & Son Funeral Home & Cremation, Inc. ("Respondent") is a permitted provider of Prepaid Funeral Benefit contracts in the state of Oklahoma and holds permit number 44199709. Respondent's address of record is 1500 West Vandament Ave, Yukon, Oklahoma 73099.
- 3. The Insurance Commissioner has jurisdiction over the subject matter raised in this dispute and may issue penalties pursuant to 36 O.S. §§ 6123 and 6130.
- 4. Pursuant to 36 O.S. § 6130(B) the Insurance Commissioner may censure, suspend, or revoke a prepaid funeral permit or impose a fine in the amount of \$100.00 to \$1,000.00 or impose both such punishment and fine, for violating any provision of the Prepaid Funeral Benefits Act.



5. If Respondent requests a hearing in writing in this matter, pursuant to *OAC 365:1-7-1*, the Insurance Commissioner will appoint an independent hearing examiner who shall sit as a quasi-judicial officer and preside over the hearing requested by Respondent.

#### **FINDINGS OF FACT**

- 6. Pursuant to 36 O.S §6128, "Each organization shall file an annual report with the Insurance Commissioner on or before March 15 of each year in such form as the Insurance Commissioner may require, showing the names and addresses of all persons with whom contracts for prepaid funeral benefits have been made prior to December 31 of the preceding year which had not been fully discharged on December 31 and, also showing the date of the contract, the name of the bank or depository holding the trust fund and the amount of the trust fund under each contract on the preceding December 31."
- Respondent filed its 2021 annual report on or about March 14, 2022.
- 8. Respondent's 2021 annual report is missing insurance company reports and the PF-2-a form.
- 9. On or about October 17, 2022, the Oklahoma Insurance Department's Financial division ("Financial") emailed Respondent and requested the insurance company reports along with the missing Pl-2-a.
- 10. The Respondent has failed to file a PF-2-a and the missing insurance company reports.

#### CONCLUSIONS OF LAW

11. Respondent has violated 36 O.S. §6128 and 36 O.S. §6129.1 by failing to file the PF-2-a and the missing insurance company reports as part of its 2021 annual report.


#### ORDER

IT IS THEREFORE ORDERED that Respondent is FINED in the amount of TWO HUNDERED DOLLARS (\$200.00). Failure to comply with a proper order of the Commissioner will result in further administrative action.

The State of Oklahoma, ex rel., Oklahoma Funeral Board ("Board"), by and through Assistant Attorney General Kylie Cooper, files this Complaint and Notice of Hearing, alleging that the Respondents, HENNINGER-HINSON FUNERAL HOME INC, HENNINGER-ALLEN FUNERAL HOME INC., and MATT HINSON, have violated provisions of the State Funeral Services Licensing Act, 59 O.S. § 395.1 et seq. (the "Act"), and Rules of the Board, Oklahoma Administrative Code ("O.A.C.") Section 235:10-1-1 et seq. (the "Rules"), in the manner set forth below:

#### **JURISDICTION**

- 1. Respondent HENNINGER-HINSON FUNERAL HOME ("Funeral Home") is licensed by the Board, establishment license number 1095ES, and is located at 601 W Broadway, Enid, OK 73701.
- 2. Respondent MATT HINSON ("Funeral Director in Charge" or "FDIC") is licensed by the Board as a funeral director and embalmer, license numbers 2938FD and 3320EM and at all relevant times was the Funeral Director in Charge at Funeral Home.
- 3. Respondent HENNINGER-ALLEN FUNERAL HOME, INC. ("Owner") is, and at all relevant times was, the owner of record for Funeral Home. Upon information and belief, Respondent MATT HINSON is the owner and registered agent for Respondent HENNINGER-ALLEN FUNERAL HOME, INC.
- 4. The Board has jurisdiction over Respondents pursuant to 59 O.S. §§ 396.2a(9) and (11). See also 59 O.S. § 396.12f(F).

#### **FACTUAL ALLEGATIONS**

- 5. On or about May 15, 2023, Board staff received an Amended Conditional Administrative Order in State of Oklahoma, ex re. Glen Mulready v. Henninger-Allen Funeral Home Inc, dba Henninger-Hinson Funeral Home, Case No. 23-0204-DIS (Exhibit "A"). This Order alleged that Henninger-Hinson Funeral Home failed o file a completed 2021 annual report, in violation of 36 O.S. § 6128 and 36 O.S. § 6129.1.
- 6. On May 18, 2023, Board staff filed a complaint with the Board, alleging that Respondents were in violation of O.A.C. 235:10-7-2(5) by failing to comply with the requirements of the

Oklahoma Statutes and Rules of the State Insurance Commission. The Board provided Respondents with the Notice of Complaint via certified mail.

- 7. On July 10, 2023, Respondents filed their response to Complaint 23-71 with the Board. Respondent's counsel stated that the \$500 fine was paid and the annual report was submitted.
- 8. By public vote during the meeting on August 10, 2023, the Board found probable cause to file a formal complaint against Respondents for the violations alleged herein.
- The prosecution has sufficient evidence which, if presented to the Board at an evidentiary hearing, would constitute clear and convincing evidence of the alleged violations.

#### ALLEGED CONCLUSIONS OF LAW

- 10. Respondents violated O.A.C. 235:10-7-2(5) by failing to comply with the requirements of the Oklahoma Statutes and Rules of the State Insurance Commission pertaining to pre-need funeral service arrangements.




