IV. Certified Healthy Updates and Voting/Julie Dearing:

Julie Dearing presented Certified Health Updates.

- 1) Feb 10 was the last day for Certified Healthy applications.
- 2) 1000+ applications across 7 programs.
- 3) More recruitment was performed this year. Performed a Gov Delivery with approx. 3500 recipients that have never participated in the Certified Healthy program. Early childhood providers, schools and congregations to increase the applicants in those areas. Used social media and paid advertising.
- 4) Major barrier this year is a new application platform isn't user friendly and daunting to use.
- 5) Clone feature is no longer available causing an increase in application processing time.

Next Steps:

- 1) Analyze applications to determine level of certification. If not an Excellence level, applicant receives a report on how to move into the Excellence category.
- 2) Notifications will go out in May 2023 to inform applicant of their level.
- 3) 20-year Anniversary Celebration event will be in the fall and all awards will go out to recipients at that time.

Morgan Hamilton/Presenting Proposed Changes for Next Certified Healthy application period:

Include a link on the survey for the Dementia Friendly America Program on the Community, Congregation, Campus and Business to include a line on the survey that says, "Are you are partner for Dementia Friend America?" and a link that would take the applicant to the Dementia Friend America website. On the website they would be able to apply every year with the Dementia Friendly America Program. Only requirement is the applicant has Dementia Friendly America Program come in once a year for a presentation. This would help increase the Dementia Friendly America program for Dementia awareness.
