Opening Discussion:

Andrea Rooks

Presentation by Fahad Khan:

Oklahoma Cancer Prevention and Control Plan 2017-2022

- 1) Hand out was given on Intermediate-term Outcomes. Reviewed and discussed all the information for the Baseline year of 2017 and the Target year of 2022 for Human Papillomavirus, Obesity, Tobacco, and Cancer.
- 2) Discussed the need to adjust targets for each of the four workgroups so the goals are realistic and obtainable. The work groups are the ones responsible to set those realistic and obtainable targets.

- 3) Discussed how OCCN programs need to collaborate and align with other similar state programs to share information, get more accurate data and not repeat work that maybe the other program has done, and can share the outcome of information.
- 4) Fruit and vegetable consumption data was discussed.
- 5) Reviewed the Long Term Outcomes with a base line of 2016 and target of 2022 and the Incidence data.
- 6) Work groups to set screening and mortality rates for lung cancer.
- 7) Monitoring of all smoking to include medical marijuana and all tobacco products to include smokeless tobacco and e-cigarettes need to be done.
- 8) Discussed other cancers that are not included with the OCCN work groups, how they are being implemented into the OCCN work groups and implementation of the other cancers as the OCCN grows. Discussed how the OCCN needs to get a solid footing and then bringing in other cancers.
- 9) Discussed that work groups need to do strategic planning
- 10) Work groups need to report out at the end of every meeting on what their group is working on and the status of the work.
