May Executive Meeting Review

Dr. Doescher:

- Expanding membership and recruitment Statewide (important to not make it too cancer center-centric)
- Increase State Cancer Control Plan focus
- Re-engagement of OCCN members (although the month of July may not be the best attempt)
- HPV vaccination opportunities;
 - May: In conjunction with Cherokee Nation, research proposal submitted to increase adolescent HPV vaccination using implementation science (to be reviewed in January 2022), one year National Institute of Health (NIH) opportunity to work with Native American partners
 - June: Proposal submitted Cherokee Nation Comp Cancer Control to increase Cancer Center collaboration (including OCCN), evidence based interventions, should see rapid turn-around (est Sept 2021) and possible future discussion for OCCN

- OK State Tobacco Plan Presentation

Strategic Planning

June OCCN Meeting Workgroup Breakout Outcomes

Cervical Cancer/HPV Vaccine Workgroup, Stephanie Pharr:

- Current projects and supplements i.e., HPV opportunities (see above)
- HPV Back On Track Series (4-6 webinars focusing on providers or parent/guardians)
- Kashlie Olsen (OKPCA/OK HPV Roundtable/OCCN Member) to meet with steering committee to discuss possible roll-out for Fall 2021

- Medicare expansion (Breast and Cervical program enrollment)
- Potential HPV/Covid-19 Vaccination Event in Fall 2021
- OCCN membership recruitment for Primary Care Provider and School Nurse
- Accompanied Cristen Hartman (OSDH Immunization/OCCN Member) at HPV Campaign meeting

HPV Campaign, Andrea Rooks:

- Hosted an informal meeting with Stephanie Pharr, Cristen Hartman, and Jennifer Gingerich
 - Proposed strategy to target Oral Health Providers (absent of usual CEU incentive)
 - Strategy to compliment Workgroup, Stephenson Cancer Center, and OSDH Programs (Comp Cancer, Take Charge!, and Immunization Services) goals/objectives

Breast Cancer Workgroup, Heather Carter:

- Increasing screening behaviors (decline since Covid-19)
- Releasing Mobile Mammography Coach and adding events to calendar
- Timeliness of care issue (pre-menopausal care with menstrual cycles)
- Article Review “Prolonged Time from Diagnosis to Breast-Conserving Surgery...” (will share)

Lung Cancer/Tobacco Cessation Workgroup, Chantel Hartman:

- Submitted comment on behalf of the OCCN for the Centers for Medicare and Medicaid Services (CMS) Public Comment for Reconsideration of the National Coverage Determination for Lung Cancer Screening
- Andrea Rooks will share)
- Two major focus areas for this year; Increasing Access and Reducing Stigma
 - DeLynn Fudge, TSET/OCCN Member assisting with OUSCC patient input group to gain insight to better assist them when it comes to cancer overall and being an asset to those individuals (meeting scheduled next or following week)
- CMS/LCS Public Comment, Andrea Rooks:
 - Congratulations to Chantel Hartman, Alexis Burris, and Dr. Doescher as this collaborative effort was the first of this year in regards to receiving recognition as the OCCN
 - Thank you to Tia Yancey for bringing this opportunity to our attention
- CMS/LCS Public Comment, Dr. Doescher:
 - Shout-Out to Chantel and Alexis for letter development (leaving only light copy editing)
 - If supported by OCCN, it is important for the network to be involved at this level

Colorectal Cancer Workgroup, Dr. Doescher:

- Changes in the harmonization and Colorectal Cancer Screening Guidelines (ages 45-49 year olds now have category B recommendation, remains a category A for 50-75 years)
- Need to be thinking how OCCN will approach this expansion and incorporate into the new plan (ACS already incorporates new age recommendation)
- Health Care Plans and Provider Performance Evaluations may not be held to the new age group for a while (similar to Lung Cancer Screening guideline expansion), unsure of reportable timelines but should consider
- Re-engagement/rejuvenation with the Oklahoma Colorectal Cancer Coalition and OCCN

- Active grant funding to increase colorectal cancer screening with tribal entities
- In Development;
 - Partnership with new OU Professor FIT Cards Testing with Mobile Mammography Units
 - Partnership with FQHC's in Eastern and Southeastern Oklahoma (FIT Testing with mobile mammography and developing Smart Phone reminder add-ons)
- Oklahoma is estimated as 45-46th worst in the Nation for Colorectal screening (BRFSS)
- May address awareness strategies within Workgroup to target male population (mortality rates higher, present late stage diagnosis more, and screened less)

Closing Discussion/Remarks

Dr. Doescher:

- NCI goals include increasing clinical trials and addressing cancer survivorship across the spectrum (including mental health)
- U.S. statistics show one of the leading chronic conditions has become Cancer Survivorship (est. 26 million plus people who have had cancer in the U.S. by 2030, over 30 million by 2040)
- People live longer with cancer now so it is becoming widely recognized that we need to do a better job addressing the needs of survivorship
