




















Variant Proportions by Region, Dates of Specimen Collection: March 27, 2023 - April 5, 2023, (N=52):















Cumulative death rate of reported COVID-19 cases





Cumulative death rate of reported COVID-19 cases in last 7 days



Weekly number of deaths (from all causes)


