# Neurologic Complications of Influenza in Pediatric Patients: A Call for Cases

## **Recommendations for Clinicians**

## Call for Cases

CDC is investigating reports of pediatric influenza-associated encephalopathy and encephalitis (IAE), including acute necrotizing encephalopathy (ANE). In January 2025, the CDC was notified of several anecdotal reports of pediatric cases of influenza-associated ANE, including two deaths. There is currently no national surveillance for IAE or ANE, and it is not known whether reported cases are within or above expected ranges. An <a href="MMWR">MMWR</a> was published on February 27, 2025, that contains additional information regarding this situation, including some clinical recommendations.

Please contact the Oklahoma State Department of Health (OSDH) **Epidemiologist-on-Call at (405) 426-8710** if you or your facility have encountered or know of IAE or ANE cases that have occurred in Oklahoma that meet the following criteria:

- 1. Age <18 years AND
- 2. Admitted to an acute care hospital *or* pronounced dead in an emergency department between October 1, 2024, and May 30, 2025, AND
- 3. Laboratory-confirmed influenza virus infection within 14 days preceding hospital presentation, during hospitalization, or in respiratory specimens collected post-mortem AND
- 4. Documented neurologic abnormalities (meets one or more of the following):
  - a. Diagnosis of encephalopathy or encephalitis
  - Neurologic signs or symptoms including but not limited to seizures, altered mental status, delirium, decreased level of consciousness, lethargy, hallucinations, or personality changes lasting >24 hours
  - c. Neuroimaging abnormalities such as brain edema, brain inflammation, or brain lesions
  - d. Electroencephalogram abnormalities
  - e. Abnormal brain autopsy findings, if available, for children who died

## Influenza Reporting Requirements in Oklahoma

Health care providers and laboratories are required to report the following to OSDH:

- Influenza-associated hospitalizations and deaths (within one business day)
- Unusual disease or syndrome, such as a severe presentation of influenza, including cases of suspected influenza-associated encephalopathy or encephalitis (within one business day)

Health care providers should report influenza-associated hospitalizations and deaths in PHIDDO. In addition, any unusual or severe presentations of influenza, including suspected influenza-associated encephalopathy or encephalitis, should be reported in PHIDDO and followed up with a call to the **OSDH Epidemiologist on Call at** (405) 426-8710 to ensure timely coordination and investigation.

### **Recommendations for Laboratories**

## Specimen Submission

In addition to the recommendations within OK-HAN\_419 - Accelerated Subtyping of Influenza A in Hospitalized Patients, the OSDH recommends submitting specimens from patients with suspected IAE and ANE to the OSDH Public Health Laboratory (PHL) for subtyping and further analysis. ## Categories of Health Alert messages:

#### **Health Alert**

Provides vital, time-sensitive information for a specific incident or situation; warrants immediate action or attention by health officials, laboratorians, clinicians, and members of the public and conveys the highest level of importance.

### **Health Advisory**

Provides important information for a specific incident or situation; contains recommendations or actionable items to be performed by public health officials, laboratorians, and/or clinicians; may not require immediate action.

#### **Health Update**

Provides updated information regarding an incident or situation; unlikely to require immediate attention.

#### **Health Info/Event**

Provides general public health information; unlikely to require immediate action.
