- 5. Discussion, consideration, possible action, and vote to......Sean Lauderdale, Chair
 - RTAB attendance was discussed. Mr. Henke shared that Dr. Cody turned in a new ARF for TeamHealth. Yaz will reach out to Purcell Municipal Hospital. Mr. McLemore shared the bylaws has verbiage to remove Board Members if they don't attend. He will also contact Prague Hospital. Jason Likens will reach out to Wadley's EMS. Mr. Henke will check into Cornerstone.
 - Solicit presentations for Region 6 RTAB Mr. Lauderdale asked to solicit presentations from the region. Mr. Likens suggested whole blood and shared David Howerton is willing to do a whole blood presentation but asked to present it later in the year because they are gathering data. Mr. Likens shared for those doing a presentation in Region 6 is only required to present in Region 6. In the past whoever did a presentation was asked to present it statewide.
