5. Reports

- Jeremy McLemore shared with the committee that RPC did meet this morning with primary discussions about the ACS state survey findings but they are not yet back so we will have to wait until November when hopefully they will be back. Also discussed was adding a blast injury section to the current burn plan to differentiate blast from trauma. Continuation of the BIG guidelines will continue to be implemented into reliable data for Oklahoma. Voting will take place at the next quarterly meeting for implementing a whole blood committee consisting of region 2 ,4 and 7 for resources of the whole blood for 2026. The RPC will also review the trauma plan.
- Judy Dyke shared with the committee that CQI has not met yet. Dr. Campbell has been sending out emails making sure the members are still members. Norma shared that some regions have gone ahead and started meeting. This will be up to the regions as to when they want to meet. The regions may schedule when they want to meet and Norma will be there. This will be up to the committee to schedule their own meetings. The regions will also decide what cases they want to discuss.
- Region 7 Response Coordinator was not in attendance so there was no report.

6. Cameron Richardson shared with the committee he did not have an update. The state stroke plans is still waiting for EMResource to update for stroke but there has been nothing posted.

7. EMS For Children representative, Bobbie Keith shared they are back on track for autism training. If anyone is interested they can contact Bobbie.

8. A presentation from Pulsara CEO, Dr. Woodson, was given regarding the benefits of Pulsara. Most of the agencies in Oklahoma who currently use Pulsara, uses Pulsara 1 for ED and EMS. Dr. Woodson presented helpful information on what Pulsara was capable of and how it would help EMS and hospitals communicate. Pulsara has been talking to the State about getting a statewide plan referred to as total care. Questions were answered at the end of the presentation.

9. A presentation was given by Dr. Behm on the Accuracy of Prehospital Trauma Priority Scores in a Rural Community Hospital setting. David Behm, DO, Associate Program Director, EM Residency, Comanche County

Memorial Hospital. Dr. Behm's presentation included research that shows that more than half of all priority 1 patients are missed. The data for this research shows that the Southwest Region 3, which has a population of over 400,000 people and more than a dozen EMS agencies. Comanche County Memorial Hospital (CCMH) receives more than 100 trauma patients each month. The data included EMS prehospital patient care report paired with CCMH ED reports. Extracted from the EMS PCR were the Trauma Priority Score (TPS) and variables of age, gender, night vs day, EMS agency, licensure of medic, and mechanism of injury. After reviewing the PCR and the ED chart an accurate TPS is decided upon and compared to the TPS in the EMS PCR. Results are 3563 paired EMS PCRs and ED charts with 812 of the 3563 EMS PCRs had no TPS (22%). Element of Priority 1 most overlooked was sustained tachycardia (71%). Elements of Priority 2 most overlooked were transient LOC / AMS (48%) and multiple comorbidities (40%). This is a study unique to Region 3 Southwest. Comments and critique are welcome.

10. Presentation: Brain Injury Guidelines Addendum (BIG) by Dr. Shellenberg

Dr. Shellenberg introduced himself and presented the BIG process that region 7 RPC has been working with for about 1 year. A lot of his content comes from the current ACS guidelines. Dr. Shellenberg started with statistics for traumatic brain injuries. He discussed what went into the process they use at the Saint Francis in the treatment of traumatic brain injuries. Dr. Shellenberg discussed the BIG 3 process they use for the treatment of traumatic brain injuries. High risk patients need to be transported to the highest level of care. He also stated the current recommendations are to break down the GCS into individual scores and focus more on motor skills, any motor skill less than 6 need to be rapidly transported to highest level of trauma care for treatment. She provided a list of criteria with a combined total GCS score of less than 13 that need to be transported to the highest level of trauma care. Dr. Shellenberg discussed considerations for the Older Adults as well as pediatric patients. He briefly discussed the standard and pediatric Glasgow coma scales. The brain injury guidelines recommended and used at Saint Francis. Dr. Shellenberg would like to see facilities and agencies familiarizing and using these guidelines.
