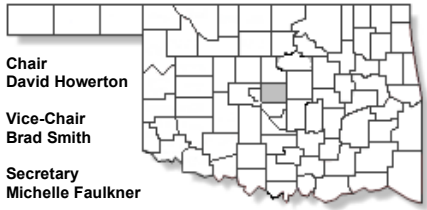
1. Brad Smith, Chair, called the meeting to order at 8:30 a.m.
