- Espa Bowen is the Director of Health Resources Development Services (HRDS)
- Beginning November 1<sup>st</sup>, 2021 licenses for Assisted Living, Continuum of Care, Residential Care, and Adult Day Care will go to a 3 year license

4. PHIDDO/NHSN Reporting

Jeneene Kitz

- Still experiencing issues of reporting point-of-care (POC) testing
- Reporting positive results within 24 hours is important for contact tracing/case investigation
- Required reporting:

- **Form 283:**
  - All Long Term Care Facility (LTCF) types must report positive test results from on-site point of care testing (collected and tested in your building) AND positive off site laboratory results received from hospital or reference lab
  - Form 283 does not meet all the reporting requirements of NHSN or PHIDDO/SpringML
  - Check to make sure you are not using the old Form 283 as it does not have the correct phone numbers
  - New Form 283 can be located at <https://oklahoma.gov/content/dam/ok/en/health/health2/aem-documents/protective-health/long-term-care-services/forms/ltc-form-odh-283-fillable-incident-report-form.pdf>
- **NHSN:**
  - All SNF/NF report ALL point of care (POC) test results (negative & positive) you conducted inside the facility
  - You do not report the results from a hospital, physician's office or reference lab. They conducted the testing and they will be reporting the results
  - This meets the requirements of CLIA and Acute Disease reporting
  - Must have a Level 3 grid card. If you don't have a grid card, you must report to PHIDDO/SpringML
  - If you have Level 1 access, you can go to the section *Increasing LTCF SAMS Level Access* <https://www.cdc.gov/nhsn/ltc/covid19/sams-access.html>

- **PHIDDO/SpringML**
  - SpringML is a platform to upload your results into PHIDDO
  - You will continue to use SpringML when the system is converted over to MTX
  - Non-nursing home facilities (or those with no NHSN Level 3 access) report ALL point of care test results (negative & positive) you conducted inside the facility
  - You do not report the results from a hospital, physician's office or reference lab. They conducted the testing and they will be reporting the results
  - This meets the requirements of CLIA and Acute Disease reporting

- If you are doing POC testing, you must have a CLIA Certificate of Waiver with all antigen testing types or modalities you are using. For CLIA assistance: 405.426.8470 or Email [medicalfacilities@health.ok.gov](mailto:medicalfacilities@health.ok.gov)

## 5. Testing Supplies/Big Commerce

- MyBigCommerce is available if you have a need for testing supplies
- Orders will be filled and shipped on an as-available basis, so your request will be reviewed
- Please check the correct type of facility testing kits when ordering or the order will be denied
- New COVID antigen test – CareStart
- BinaxNOW testing kits are not available
- Must add CareStart to your CLIA waiver or your request will be denied
- When making your request, include your CLIA certificate number, number of residents (census) and number of staff you will be testing, and if your facility is experiencing an outbreak, or you will receive a notification and the order will be denied

- COVID-19 Booster Shots

- Facility support guidance can be found in *Federal Long-Term Care COVID-19 Vaccine Access Campaign* at <https://healthokgov.app.box.com/s/cpjlqmb2n9x0cfx7oncupw5mioc4yp6j>
- If you are having difficulty accessing the vaccine or administering it, reach out to LTC
- If your pharmacy is having trouble accessing the vaccine, have them reach out to LTC
- Vaccine Mandates
  - CMS has not provided any additional information
  - They are in the rule making process and do not provide any communication during this time
  - As soon as guidance is provided, we will make sure you receive it
- Visitation
  - Still seeing facilities completely lock down when they have one COVID positive in the building
  - We want to remind you of the updated guidance related to targeted testing for outbreak testing
  - Refer to the QSO-20-39-NH guidance which has not changed
  - CMS has said they encourage visitation and creativity should be used to allow it
  - Remember to consider the needs of your residents and compassionate care requirements
  - State legislation requirements and obligations for a facility not to lock down for an extended period of time and that the facility must provide notification of your situation
- 75 Hour CNA training requirement
  - QSO-20-17-NH speaks to the 75 hours of training in certain areas that are critical in performing the CNA role, including residents rights and infection control
  - The waiver gave flexibility on how the training occurred and it did not have to happen in a classroom
  - You still have to track the 75 hours of training
  - Oklahoma also has a requirement for 10 hours of dementia training
