2. Bat Rabies Prevention

Mike Manell

- Mike is the Assistant Director for Infectious Disease Prevention and Response (IDPR)
- Rabies is a viral disease that infects the nervous system of humans and warm-blooded mammals and is considered 100% fatal if left untreated
- The treatment for rabies is post-exposure prophylaxis (PEP); a series of shots over 14 days. Once symptoms develop, there is no effective treatment
- Bats can gain entry to a space through openings as small as 1/4 inch and will return to their maternal roost if entry is available
- High risk categories for exposures: (You may not feel the bite)
 - Sleeping
 - Heavily medicated or intoxicated
 - Non-verbal or mentally incapacitated
- When bats are found, do not release the bat, capture it for testing and call the IDPR epidemiologist-on-call for guidance

3. COVID-19 FAQs

- Rhonda is the Lead Long Term Care Infection Preventionist with Infectious Disease Prevention and Response
- Flu season
 - OSDH [Viral View \(oklahoma.gov\)](#) provides up to date surveillance data for Influenza, COVID, and RSV
 - Flu, COVID-19, and RSV have the potential to co-circulate. Double check and don't forget there may be need to test for both
- Current COVID CDC Recommendations

 - Definition has not changed - ONE POSITIVE COVID-19 resident or staff member begins your facility's outbreak response.
 - Outbreak Testing Process - Contact Tracing and Broad-Based Testing
 - Duration of isolation – removal of resident from Transmission-Based Precautions (TBP) and staff Return to Work (RTW)
 - Guidance for managing staff with infection or exposure and the staff RTW criteria can be found in [Interim Guidance for Managing Healthcare Personnel with SARS-CoV-2 Infection or Exposure to SARS-CoV-2 | COVID-19 | CDC](#)

- MDS key updates
 - Section GG: Functional Abilities - Requirement to choose at least one Discharge Goal has been deleted
 - Section H: Bladder and Bowel - Female external catheter systems should be coded as external catheters (H0100B)
 - Section I: Diagnoses Updates – clarification of coding I2100-Septicemia
 - Section N: Medications – added N0415K1. Anticonvulsant and N0415K2. Anticonvulsant
 - New Data Element: O0350.Resident’s COVID-19 Vaccination is up to date

- Philip is the Director of Long Term Services
- Form 283 Reminders
 - Continuum of Care Facilities- ensure to document correct Facility ID (example: CC1234 vs CC1234AL)
 - Ensure correct Facility ID, especially with facilities with similar names, or facilities that are part of the same company (example Cottage #1 has ID: NH1234, Cottage #2 has ID: NH1235)
 - Ensure to document resident name(s) and staff name(s) if applicable
 - Ensure to include relative history, resident physical and/or psychosocial outcomes, and protective measures on initial incident report
 - Form 283 was revised in July 2024. Please discard any older forms you may be using and begin using the revised version located at [ltc-form-odh-283-fillable-incident-report-form.pdf \(oklahoma.gov\)](#)
