REPORT OF THE INTERIM COMMISSIONER

Preston Doerflinger, Interim Commissioner of Health, has been focused on the agency finances and worked to secure 30 million dollars from the legislature. This money allowed the agency to avoid default on payroll and to address ongoing financial issues. There has been an emphasis on the needs and concerns of employees, as well.

Mike Romero, Chief Financial Officer for the State Department of Health, shared that he will be developing a financial reporting enterprise for the Board of Health. This system will utilize the Governmental Accounting Standards Board (GASB) techniques and will ensure accountability as well as follow requirements set by the code of federal regulations. Mr. Romero hopes to have this reporting system available in the near future.

Ms. Burger asked if this report would include complete financial statements such as balance sheets and income statements. Mr. Romero responded that it would include that information.

Dr. Krishna asked how the OSDH auditing process could be more accurate and effective. Mr. Romero responded that this will be looked at as the internal controls framework is developed.

#### REPORT OF THE EXECUTIVE COMMITTEE

Ms. Burger affirmed the Board's commitment to public health. The Board provides strategic guidance to the agency and works to ensure the strategic plan aligns with the Oklahoma Health Improvement Plan (OHIP). Ms. Burger shared results of the 2017 national health rankings which showed positive health improvements for Oklahoma. Even in this difficult time, Ms. Burger acknowledged that public health employees are dedicated and will continue to serve the people of Oklahoma. The Board was disappointed to learn about the agency's financial situation and is working with the Attorney General's office to move forward with the investigation. It is important to reestablish a firm financial foundation as the agency also works to regain confidence from the public and employees. The Board is dedicated to working with Mr. Doerflinger in these efforts.
