QIES Help Desk Upcoming Training:

- The ***MDS 2-Day Updates and Clinical Coding Guidelines*** training is scheduled for September 20-21, 2018 at Gordon Cooper Technology Center in Shawnee, OK. This training will look at the *NEW RAI Manual* updates, MDS 3.0 clinical coding, State Optional items, Corrections, and a brief overview of CAAs and Care Plans. A copy of the *NEW RAI Manual* will be needed at the training in either printed or electronic format. *This new manual will be released during September; a link to the manual will be provided as soon as it becomes available by CMS. **Registration is now open until September 5, 2018, or until maximum capacity is reached.***

- **SAVE THE DATE!** The ***MDS Quality Assurance/Performance Improvement (QAPI)*** training is scheduled for December 13, 2018 at the Oklahoma City-County Health Department in Oklahoma City, OK. QAPI programs are critical to improving the quality of life, and quality of care and services delivered in nursing homes. Attendees will receive an overview of the PDSA cycle, flow charting, and root cause analysis, which are valuable tools in your QAPI planning process. Additionally, you will learn how to use data from your CASPER reports as indicators to improve resident outcomes and correct potential problem areas. Registration will be open from October 8 – November 19, 2018, or until maximum capacity is reached (seating is limited).

- The CMS QIES Technical Support Office (QTSO) website is under redesign. Expect to see a new user-centered design and organization in the next few weeks when you visit the QTSO website. - On July 31, 2018, CMS issued the final rule outlining Fiscal Year (FY) 2019 Medicare payment updates and quality program changes for skilled nursing facilities (SNFs).

Three major provisions of the final rule include changes to the Prospective Payment System (PPS), the SNF Value-Based Purchasing Program (VBP), and the SNF Quality Reporting Program (QRP).

Effective October 1, 2019, CMS will begin using a new case-mix model, the Patient-Driven Payment Model (PDPM), which is designed to improve the incentives to treat the needs of the whole patient.

CMS indicated the PDPM model will focus on clinically relevant factors by using the ICD-10 diagnosis codes and other patient characteristics, such as Section GG, as the basis for patient classification. Therefore, the accuracy of the MDS is critical and continues to play a major role in financial implications for nursing homes.
